No. S.R.O. 3-L/83.—In pursuance of the Proclamation of 24th March, 1982, and in exercise of all powers enabling him in that behalf, the Chief Martial Law Administrator is pleased to make the following amendment in the Non-Gazetted Employees (Special Branch and District Special Branch) Recruitment Rules, 1979, namely:

In the aforesaid Rules, in the Schedule, after Sl. No. 5, the following new provision shall be added, namely;—

"6. Librarian, S.B.

Not exceeding 27 years.

By direct recruitment, Bachelor's degree from a recognised University with Diploma in Library Science.".

No. S.R.O.4-L/83.—In pursuance of the Proclamation of 24th March, 1982, and in exercise of all powers enabling him in that behalf, the Chief Martial Law Administrator is pleased to make the following rules, namely:—

- 1. Short title.—These rules may be called the Non-Gazetted Staff (Population Information Service) Recruitment Rules, 1982.
- 2. Definitions.—In these rules, unless there is anything repugnant in the subject or context,—
 - (a) "appointing authority" means the Government and includes any
 officer authorised by the Government to make appointment to such
 post;
 - (b) "Commission" means the Bangladesh Publice Service Commission;
 - (c) "Probationer" means a person appointed on probation to a specified post;
 - (d) "recognised university" means a university established by or under any law for the time being in force and includes any other university declared by the Government, after consultation with Commission, to be recognised university for the purpose of these rules;
 - (e) "requisite qualification" in relation to a specified post, means the qualification laid down in the Schedule in relation to that post;
 - (f) "Schedule" means the Schedule annexed to these rules; and
 - (g) "specified post" means a post specified in the Schedule.
- 3. Procedure for recruitment.—(1) Subject to the provisions of the Schedule, appointment to a specified post shall be made by direct recruitment.
- (2) No person shall be appointed to a specified post unless he has the requisite qualification and he is also within the age limit laid down in the Schedule for the post.
- 4. Appointment.—(1) Subject to the provision of the Bangladesh Public Service Commission (Consultation) Regulations, 1979, no appointment to a specified post shall be made except upon the recommendation of the Commission.
 - (2) No person shall be eligible for appointment to a specified post, if he-
 - (a) is not a citizen of Bangladesh or a permanent resident of Bangladesh;
 and
 - (b) is married to, or has entered into a promise of marriage with, a person who is not a citizen of Bangladesh.

- (3) No appointment to a specified post by direct recruitment shall be made until—
 - (a) the person selected for appointment is certified by a medical officer to be medically fit for such appointment and that he does not suffer from any such organic defect as is likely to interfere with the discharge of the duties of the specified post; and
 - (b) the antecedents of the person so selected have been verified through appropriate agencies and found to be such as do not render him unfit for appointment in the service of the Republic.
 - (4) No person shall be recommended for appointment to a specified post unless-
 - (a) he applied in such form, accompanied by such fee and before such date as was notified by the Commission while inviting applications for the specified post; and
 - (b) in the case of a person already in Government service or in the service of a local authority, he applied through his official superior.
- 5. Probation —(1) Persons selected for appointment to a specified post against a substantive vacancy shall be appointed on probation for a period of two years from the date of substantive appointment:

Provided that the appointing authority may, for reasons to be recorded in writing, extend the period of probation by a period or periods so that the extended period does not exceed two years in the aggregate.

- (2) Where, during the period of probation of a probationer, the appointing authority is of opinion that his conduct and work is unsatisfactory or that he is not likely to become efficient, it may, before the expiry of that period, terminate his service.
- (3) After the completion of the period of probation including the extended period, if any, the appointing authority,—
 - (a) if it is satisfied that the conduct and work of the probationer during his period of probation has been satisfactory, shall, subject to the provisions of sub-rule (4), confirm him; and
 - (b) if it is of opinion that the conduct and work of the probationer during that period was not satisfactory, may terminate his service.
- (4) A probationer shall not be confirmed in a specified post until he has passed such examination and undergone such training as the Government may, from time to time, direct.

SI. Name of the Age limit. Qualification.

1 Research Assistant. Not exceeding 27 Byears, relaxable in case of persons already in Government service.

Bachelor's Degree with Mathematics or Statistics as one of the subjects from a recognised University. Candidates having experience in research methodology will get preference.
