- (d) official members as under:
 - (i) Upazila Nirbahi Officer, *ex-officio*;
 - (ii) Upazila Health and Family Planning Officer, *ex-officio*;
 - (iii) Upazila Education Officer, *ex-officio*;
 - (iv) Upazila Agriculture Officer, *ex-officio*;
 - (v) Upazila Engineer, *ex-officio*;
 - (vi) Upazila Co-operative Officer, *ex-officio*;
 - (vii) Upazila Livestock Officer, *ex-officio*;
 - (viii) Upazila Fishery Officer, *ex-officio*;
 - (ix) Upazila Social Welfare Officer, *ex-officio*;
 - (x) Upazila Rural Development Officer, *ex-officio*;
 - (xi) Upazila Mass Communication Officer, *ex-officio*;
 - (xii) Upazila Revenue Officer, *ex-officio*; and
 - (xiii) Officer-in-charge, Police Station, *ex-officio*.
- (e) Chairman of the Thana Central Co-operative Association within the Upazila; and
- (f) One member (to be nominated by the Government).

(2) Until the Chairman is elected and enters upon his office, the Upazila Nirbahi Officer shall act as Chairman of the Upazila Parishad.
