### NOTIFCATION

Dacca, the 11th January 1978.

No. S. R. O. 9-L/78—The following draft of certain further amendments to the rules for regulating the grant of Certificates of Competency to Masters and Serangs of Inland Steam Vessels, published under notification No. 22-Marine, dated the 20th March 1917, which it is proposed to make in exercise of the powers conferred by section 82 of the Inland Ship ing Ordinance, 1976 (Ordinance LXXII of 1976), is hereby published as required by sub-section (1) of the said section for the information of all persons likely to be affected thereby, and notice is hereby given that the draft will be taken into consideration on or after 31st January 1978.

Any objection or suggestion which may be received from any person with respect to the said draft before the date specified will be considered by the Government.

#### Draft Amendment

In the aforesaid rules, after rule 37, the following new rule 38 shall be added, namely:—

"38. Time spent in the Training Centre to be Counted for appearing in higher examination.—Half the time spent by the Cadets in the Deck Personnel Training Centre, Bangladesh Inland Water Transport Authority, Narayangon, or a period of one year whichever is lesser, shall be counted as seatime and helm man service for the purpose of their appearing in the next higher examination under these rules."
