Section I

NOTIFICATION

Dacca, the 19th January, 1978.

No. S.R.O. 11-L/78.—In exercise of the powers conferred by the proviso to Article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Public Service (First) Commission as required by clause (2) of Article 140 of that Constitution, is pleased to make the following amendment in the Bangladesh Engineering Services (Building, Electrical and Mechanical) Rules, 1976, namely:—

In the aforesaid Rules,-

- (a) in Schedule 1, against serial 2, for entry in the second column the following shall be substituted, namely:—
 - "In case of promotion, by the Government on the recommendation of the Superior Selection Board constituted by the Establishment Division Resolution No. 7, 74/95-228/96-328, dated the 29th August, 1975, and in case of direct recruitment, by the Government on the recommendation of the Commission.":
- (b) in Schedule III, against serial 7, for entry in the second column the following shall be substituted, namely:—
 - "By promotion from amongst the Executive Engineer (Electrical) of the Directorate and, if none is found suitable for promotion, by direct recruitment and, in case no suitable person is available for appointment by direct recruitment also by transfer of service on deputation from other Government Offices".;
- (c) in Schedule IV, against serial No. 7 in column 1, in column 4 in paragraph (ii), for the words "in the gazetted rank in the Public Works Department" the words "in the field of operation, maintenance and repairing" shall be substituted.
