#### NOTIFICATION

Dhaka, the 3rd January, 1983

No. 18-MF(XI)/IP-12/82.—Whereas M/s. Marpro Ltd., Marshall House 5, Kingston Road, Tolworth Surbiton Surrey, UK KT5 9PE, England represented by their Local Agent M/s. Haque Enterprise, 74, Motijheel C.A., Dhaka-2 (the Seller) entered into a contract with the Government of the People's Republic of Bangladesh represented by Food Division of the Ministry of Food on 13th Oct. ber 1982 for supply of 20,000 M.T. wheat on C&F basis.

2. And whereas the L/C was opened under the terms of the contract in favour of M/s. Marpro Ltd.;

- 3. And whereas the Seller chartered a vessel which, because of its indebtedness, stood arrested on arrival at the port of loading (Antwerp, Brussels) and whereas the Seller suppressed the fact of arrest, back-dated the bill of lading and negotiated the same before the loading was completed;
- 4. And whereas the Seller violated the terms of the contract by denying their responsibility to carry and deliver the wheat to the port of destination although they encashed the L/C which covered both the cost of wheat and the cost of freight;
- 5. And whereas the Government have found that M/s. Marpro Ltd., in collusion with their local agent M/s. Haque Enterprise have defrauded the Government causing huge financial loss to the latter;
- 6. And whereas the Government have decided to blacklist the said M/s. Marpro Ltd., Marshall House, 5, Kingston Road, Tolworth Surbiton Surrey, UK KT5 9PE, England and M/s. Haque Enterprise, 74, Motijheel C.A., Dhaka—2 Local Agent (The Seller).
- 7. Now, therefore, Government is pleased to direct that M/s. Marpro Ltd., London and M/s. Haque Enterprise, Dhaka be blacklisted and be debarred from doing any business in Bangladesh.
