

#### GOVERNMENT OF THE PEOPLE'S REPUBLIC OF BANGLADESH

#### RESOLUTION

Dacca, the 18th January, 1977.

No. F. 14-2/76/61-C&S.—Whereas it is expedient to establish a Cultural Heritage Fund for the purpose of acquisition and preservation of objects of art, manuscripts and other objects of artistic and literary significance left behind by eminent artists and literateurs and to provide for matters connected therewith:

It is, therefore, resolved that a Fund to be called the Cultural Heritage Fund be hereby established in the Ministry of Education (Cultural Affairs and Sports Division) and a Committee to be called the Cultural Heritage Fund Committee be constituted with the powers and functions specified below:—

- 1. Definitions.—In this Resoultion, unless there is anything repugnant to the subject or context,—
  - (a) "Committee" means the Cultural Heritage Fund Committee;
  - (b) "Fund" means the Cultural Heritage Fund;
  - (c) "Member" means a Member of the Committee.
  - 2. Fund.—The Fund shall comprise—
    - (a) grants from Government; and
    - (b) contributions from the public.
  - 3. The Committee. The Committee shall consist of-
    - (a) the Minister and, if there be no Minister, the Advisor to the President in charge of the Cultural Affairs and Sports Division—Chairman.

#### Members (Ex-officio)

- (b) the Secretary, Cultural Affairs and Sports Division.
- (c) the Secretary, Ministry of Finance.
- (d) the Dean of the Faculty of Arts, University of Dacca.
- (e) the Dean of the Faculty of Fine Arts, University of Chittagong.
- (f) Principal, Government College of Arts and Crafts, Dacca.
- (g) 3 persons interested in the preservation and development of arts and literature to be nominated by the Government.
- 4. Term of office, etc.—(1) The term of office of the Members of the Committee nominated under clause (s) of paragraph 3 shall be three years from the date of their appointment:

Provided that if such a Member fails to attend three consecutive meetings of the Committee or remains out of Bangladesh for a continuous period of six months, he shall cease to be a Member of the Committee.

(2) Any Member nominated under clause (g) of paragraph 3 may, at any time, resign his office by notice in writing to the Government:

Provided that no resignation shall take effect until it has been accepted by the Government.

- (3) The Government may, at any time, by order in writing terminate the nomination of any Member, other than an ex-officio Member, without assigning any reason.
- 5. Functions of the Committee.—The functions of the Committee shall be—
  - (a) to determine the principle for utilization of the fund and to select personalities whose artistic and literary works or other objects of artistic and literary significance are to be preserved;
    - (b) to make institutional arrangement, including sanctioning of money, for acquiring and preserving objects of arts manuscripts and other objects of artistic and literary significance left behind by personalities selected under clause (a);
    - (c) to do such other acts and things as may be considered necessary or expedient for carrying out the purposes of this Resolution.
- 6. Operation of the Fund, etc.—(1) The Fund shall be maintained as a non-interest bearing reserve fund within the Public Account of Republic to which such Government contributions from the Consolidated Fund as may be provided for from time to time as well as contributions from members of the public shall be credited.
- (2) The Fund shall be operated by the Secretary, Cultural Affairs and Sports Division on the basis of sanctions accorded by the Committee and in accordance with regulations to be made under this Resolution.
- 7. Power to make rules.—The Government may, by notification in the official Gazette, make rules for carrying out the purposes of this Resolution.

- 8. Power to make Regulations.—(1) The Committee may, with the previous approval of the Government, make regulations to provide for all matters for which provision is necessary or expedient for the purpose of giving effect to the provisions of this Resolution.
- (2) All Regulations made under this paragraph shall be published in the official Gazette.

Ordered that the Resolution be published in the Bangladesh Gazette, Extraordinary.
