No. S.R.O. 30-L/83/763/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to make the following further amendment in this Ministry's Notification No. S.R.O. 233-L/82/725/Cus., dated the 30th June, 1982, namely:—

In the aforesaid Notification, after Tariff Heading No. 27.04 in column (1), and the entries relating thereto in columns (2) and (3), the following shall be inserted, namely:—

"27.06 Tar distilled from coal, from lignite or from peat and other mineral tars, including partially distilled tars and blends of pitch with creosote oil or with other coal tar distillation products

25% ad val."

 This Notification shall be deemed to have taken effect on and from the 30th June, 1982.

NOTIFICATION

Dhaka, the 27th January 1983

No. S.R.O. 31-L/83—In exercise of the powers conferred by section 10 of the Censorship of Films Act, 1963 (XVIII of 1963), the Government is pleased to make the following amendment in the Bangladesh Censorship of Films Rules, 1977, namely:—

In the aforesaid Rules,-

- (1) in rule 5, in sub-rule (4), after the words "shall work", the words "a Secretariat of the Board" shall be inserted;
- (2) in rule 8, for sub-rule (4), the following shall be substituted, namely:—
 "(4) The Board shall meet as frequently as required.";
- (3) in rule 11,-
 - (a) For the words "conveyance charges" the words "sitting fee" shall be substituted; and
 - (b) the proviso shall be omitted;
- (4) in rule 13,-
 - (a) in clause (b), the word "and" at the end shall be omitted;
 - (b) in clause (c), for the "full-stop" at the end a "semi-colon" shall be substituted and thereafter the following new clauses shall be added, namely:—
 - "(d) the film shall not in any way impair the national ideology, namely, absolute trust and faith in the Almighty Allah, nationalism, democracy and socialism meaning economic and social justice;
 - (e) the Film is not a plagiarised one;
 - (f) observe the third country rule so as to avoid impairing good relations between Bangladesh and other nations.";
- (5) in rule 14,-
 - (a) in sub-rule (3), after the word "Chairman" occurring for the second time, the words "in consultation with the members" shall be inserted;

- (b) in sub-rule (5), for clauses (a) and (b), the following shall be substituted, namely :-
 - "(a) a treasury challan of the examination fee deposited in the Bangladesh Bank under the head of Account of the Board at the rates laid down in the following table :-

- (i) Where the length of Taka 200 per 1,000 feet or the film does not exceed a fraction thereof. 3,000 feet.

Taka 600 plus taka 300 per 1,000 feet or a fraction thereof exceeding 3.000 feet.

(iii) Where the length of the film exceeds 13,000 feet.

Taka 4,500 plus taka 1,000 per 100 feet or a fraction thereof exceeding 13,000 feet. In case of foreign films, taka 4,500 plus taka 500 per 100 feet or fraction thereof exceeding 13,000 feet.

(i) Where the length of the Taka 200 per 400 feet or film does not exceed a fraction thereof. 1.200 feet.

(ii) Where the length of Taka 600 plus taka 300 the film exceeds 1,200 per 400 feet or a fracper 400 feet or a fraction thereof exceeding 10200 feet.

(b) a receipt of the screening fee deposited in a scheduled bank as advised by the Board at the following rates, if the film is to be examined at any particular projection hall of the Government. The screening fee represents the charge for service rendered by the projection hall by way of screening of films :-

- (6) in rule 16,-
- (a) in sub-rule (3) in clause (a), after the words "without excision", the words "and such excision decided by the Chairman shall be made in the office of the Board" shall be inserted;
- (b) in sub-rule (4) for the word "Board" the words "full Board" shall be substituted;
- (7) after rule 17, the following new rule 17A shall be inserted, namely :-
 - "17A. Missions to obtain permission for holding film shows.—(1) Foreign Missions intending to hold film shows or film festivals in any place, other than their diplomatic premises. Information Centres or Cultural Centres, on their own or in association with local film societies shall obtain prior permission from the Bangladesh Film Censor Board.
 - (2) Foreign Missions shall not allow its films to be used for charity shows by any organisation except with the prior permission of the Government.";
- (8) in rule 20, the words, brackets and figure "after the expiry of at least three months (90 days) from the date of Gazette Notification declaring the film to be uncertified" shall be omitted;
- (9) in rule 25, in sub-rule (1), after the word "suspension", the words "if a Film" shall be inserted;
- (10) in rule 26, in sub-rule (1), for the word "Board" at the end the word "Vice-Chairman" shall be substituted.
