THE TARIFF (AMENDMENT) ORDINANCE, 1976.

Ordinance No. IV of 1976.

AN

ORDINANCE

further to amend the Tariff Act, 1934.

WHEREAS it is expedient further to amend the Tariff Act, 1934 (XXXII of 1934), for the purpose hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamations of the 20th August, 1975, and 8th November, 1975, and in exercise of all powers enabling him in that behalf, the President is pleased to make and promulgate the following Ordinance:—

1. **Short title.**—This Ordinance may be called the Tariff (Amendment) Ordinance, 1976.

2. **Amendment of the Second Schedule of Act XXXII of 1934.**—In the Tariff Act, 1934 (XXXII of 1934), in the Second Schedule, for Item No. 1 in the first column and the entries relating thereto in the second and third columns the following shall be *substituted*, namely:—

“1. Raw jute and Meshta fibre—

(1) Raw jute—

(a) Long jute Taka 130·00 per bale of 400 lbs.

(b) Cuttings Taka 50·00 per bale of 400 lbs.

(c) Others Taka 50·00 per bale of 400 lbs.

(2) Meshta fibre Taka 50·00 per bale of 400 lbs.
