No. S.R.O. 41-5/78.—In exercise of the powers conferred by clause (a) of sub-section (1) of section 4 of the Ports Act, 1908 (XV of 1908), read with sub-section (2) of the said section 4, and in supersession of erstwhile Communication and Transport Division Notification No. PD-4(28)/53, dated the 24th June 1954, the Government is pleased to extend the said Act to the Chalna Port, the limits of which shall be as follows:

Whereas it has been made to appear to the Court that accused (1) Kabir Ahmed, son of late Altaf Miah of village Bishbagh, P. S. Senbag, district Noakhali, at present Aprupa Bastralaya, Mouchak Market, P. S. Ramna, Dacca, (2) Sultan Ahmed, son of Haji Sujat Ali Mollah, Owner of Sujata Saree Bitan, Ibrahim Mansion, 11, Purana Paltan, P. S. Motijheel, Dacca, are required for the purpose of trial in the Summary Martial Law Court, Dacca under MLR 19 in connection with Ramaa P. S. Case No. 78(9)77;

And whereas the Court has reason to believe that the said accused persons are absconding and concealing themselves to avoid appearance or arrest for the said purpose.

The aforesaid accused persons are directed to appear in the Summary Martial Law Court, Dacca Collectorate Court Building, Dacca on 4th March 1978 at 093) hours, failing which they will be tried in absentia and their property part/whole may be confiscated to the State.

Whereas you (1) Noor Islam, son of Sabar Ali Sardar, village Dadpur, (2) Isha Dhali, son of Nasiruddin Dhali, village Alapur, P. S. Debhata, district Khulna, are accused in Special Powers Act Case No. 86 of 1977 of this Court arising out of G. R. Case No. 781/75 and Kaliganj P. S. Case No. 1, dated the 1st August 1975;

And whereas Police failed to secure your arrest and produce you before this Court;

And whereas I am satisfied from police report that you are deliberately and intentionally avoiding process of Court and absconding with ulterior motive;

Therefore, I, M. Amin Choudhury, Additional Sessions Judge and Special Tribunal Court No. II, Khulna, being specially empowered under sub-section (6) of section 27 of Special Powers Act, 1974, hereby ask you to appear before this Court within 35 days from the date of publication of this notice to answer the accusation in the aforesaid Case. If you fail to appear within the said date you will be tried in absentia.

SUMMARY MARTIAL LAW COURT, JESSORE.

NOTIFICATION

Whereas it has been made to appear before me that (1) Motaleb Khan alias Motaleb Ali Khan alias Ablal Motleb Khan, son of Mohammad Ali Khan of Saruppur Chakla, P. S. Chowgacha, district Jessore, is required for the purpose of an enquiry in connection with Chowgacha P. S. Case No. 6, dated the 13th August 1977, under section 19(f) Arms Act read with MLR 10/75 in M.L.G.R. Case No. 216/77;

And whereas I have reasons to believe that the said (1) Motaleb Khan alias Motaleb Ali Khan alias Abdul Motleb Khan is absconding or concealing himself or remaining abroad to avoid appearance of the said enquiry and proceedings;

Now, therefore, in exercise of the power conferred upon me under article 3(7) of the Martial Law Regulations, 1975, I, Major Khairul Alam, Member,

Summary Martial Law Court, Jessore, do hereby direct-

(a) the said Motaleb Khan alias Motaleb Ali Khan alias Abdul Motleb Khan to appear in my Court at Jessore on the 13th March 1978, at 10 a. m. and

(b) failing which all the movable and immovable properties belonging or standing in the name of the said (1) Motaleb Khan alias Motaleb Ali Khan alias Abdul Motleb Khan shall be forfeited and confiscated to the Government of the People's Republic of Bangladesh and he will be tried in his absence.
