 - (b) the nomination of Lt. Col. Rukunul Islam Chowdhury in the said Cantonment Board of Comilla.
- No. S.R.O. 55-L/84.—Whereas a part of the regular forces of Bangladesh Army has been quartered at Shanki Para, Mouja Akua, J.L. No. 104, Police Station Kotwali, in the district of Mymensingh;

And whereas the said place is required for the service of the forces mentioned above;

Now, therefore, in exercise of the powers conferred by sub-section (1), read with sub-section (2) of section 3 of the Cantonment Act, 1924 (II of 1924), the Government is pleased to declare Shanki Para, Mouja Akua, J.L. No. 104, Police Station Kotwali, in the district of Mymensingh to be a cantonment to be called the "Momenshahi Cantonment" for the purposes of the said Act and all other enactments, and to define the limits of the said Cantonment as in the Schedule below:

BANGLADESH BIMAN CORPORATION, DHAKA.

NOTIFICATION

Dhaka, the 5th February, 1984

No. S.R.O. 56-L/84.—In exercise of powers conferred by section 30 of the Bangladesh Biman Corporation Ordinance, 1977 (XIX of 1977), the Board of Directors of the Bangladesh Biman Corporation, with the previous sanction of the Government, is pleased to make the following amendment in the Bangladesh Biman Corporation Employees (Service) Regulations, 1979, namely:—

In the aforesaid Regulations :-

- (a) in regulation 2, for clause (c), the following shall be substituted, namely:—
 - "(c) "cabin crew" includes-
 - (i) Flight Steward and Flight Stewardess.
 - (ii) Junior Purser (male and female).
 - (iii) Purser (male and female).
 - (iv) Chief Purser (male and female).";
- (b) in regulation 5 :-
 - (i) in sub-regulation (5), for the words "No person" the words "Subject to sub-regulation (6), no person" shall be substituted; and
 - (ii) after sub-regulation (5), the following new sub-regulation (6) shall be added, namely:—
 - "(6) No person shall be recruited to a post of a cabin crew under the Corporation whose age is less than 18 years and more than 22 years.";
- (c) for regulation 9, the following shall be substituted, namely:-
 - "9. Female cabin crew.—(1) In order to be eligible for appointment as female cabin crew, a candidate must be an unmarried girl.
 - (2) A female cabin crew shall remain unmarried for a period of 5 years from the date of her appointment and on completion of 5 years of service, a female cabin crew may marry after prior intimation to the Competent Authority.
 - (3) A female cabin crew shall, before the expiry of 3rd month of her pregnancy, report to the Corporation's Doctor for medical check up and shall also report to the Competent Authority in writing intimating the fact of her becoming pregnant.
 - (4) After he is satisfied that the physical state of a pregnant female cabin crew is not conducive to discharging her duties or her discharge of duties is likely to cause inconvenience to herself or

embarrassment to the passengers, the Corporation's Doctor shall certify granting of leave to the pregnant female cabin crew from the date sepcified in such certificate.

- (5) The Competent Authority shall, on receipt of the certificate given under sub-regulation (4), grant leave to a pregnant female cabin crew for a period not exceeding 9 months and out of the period of leave granted, the pregnant female cabin crew shall be entitled to maternity leave with pay for a period of 12 weeks and the balance of the period of leave shall as far as admissible, be adjusted against accumulated leave, if due, or such leave shall be treated as leave without pay.";
- (d) for regulation 11, the following shall be substituted, namely :-
 - "11. Retirement.—(1) An employee, other than a cabin crew, shall retire from service of the Corporation on the completion of the fifty-seventh years of his age:

Provided that the Corporation may extend the service of a medical officer (physician) beyond the date of his retirement for a period not exceeding three years and such extension shall be subject to such conditions, if any as may be determined by the Corporation.

(2) The age of retirement of the following cabin crew shall be as specified below, namely:—

(i) Flight Steward (Male)	45 3	rears
(ii) Flight Stewardess	 35	330
(iii) Purser and Chief Purser (Male)	 50	37
(iv) Purser and Chief Purser (Female)	 40	"
(v) Junior Purser (Male)	 45	22
(vi) Junior Purser (Female)	35	":

Provided that the retirement age of all cabin crew who are in the employment of the Corporation prior to 31st December, 1980, shall be governed by the terms and conditions under which they were employed.

- (3) Notwithstanding anything contained in these regulations, a female cabin crew having two surviving children shall, upon her becoming pregnant for third child, cease to be an employee of the Corporation.
- 11A. Optional retirement.—(1) An employee of the Corporation may opt to retire service at any time after he has completed twenty-five years of service by giving notice in writing to the Competent Authority at least thirty days prior to the date of his intended retirement:

Provided that such option once exercised shall be final and shall not be permitted to be modified or withdrawn.

(2) The Corporation may, if it considers expedient so to do, retire from service an employee at any time after he has completed twenty-five years of service without assigning any reason.

- (e) for regulation 52, the following shall be substituted, namely:-
 - "52. Termination.—(1) Service of a permanent employee may be terminated by the Corporation without assigning any reason by granting three months notice or, in lieu thereof, by payment of three months pay.
 - (2) No notice shall be required to terminate the service of an employee who is a temporary employee, part-time employee, casual employee, probationer or apprentice.".
