(2) In Annex 2 (Engineering Group of Industry), against Sl. No. 107 (Sports Goods) under Section B. Sports goods (other than leather), the existing raw material item at Sl. No. 1 (Quality timber) in col. 3 shall read as "Quality timber (Plywood and teak wood only)" and the words "Importable only by the recognised units under Sports Goods Industry" shall be inserted against this item under col. 4.
