#### RESOLUTION

Dacca, the 21st March, 1978.

No. CD/DB/12(48)/76-182.—The President has been pleased to constitute a Committee for improvement works of Sylhet Town with immediate effect.

- 1. Composition of the Committee.—The Committee shall consist of the following, namely:—
  - (1) Deputy Commissioner, Sylhet-Chairman.

## Members.

- (2) Chairman, Pourashava, Sylhet.
- (3) Executive Engineer, Roads and Highways Department, Sylhet.
- (4) Local representative of Public Works Department.
- (5) Local representative of Power Development Board.
- (6) Zilla Board Engineer, Sylhet.
- (7) President, Sylhet Chamber of Commerce.

- (8) Divisional Engineer, Telephones, Sylhet.
- (9) Executive Engineer, Public Health Engineering, Sylhet.
- (10) Additional Deputy Commissioner-Member-Secretary (Genl.), Sylhet.
- Meeting of the Committee.—(1) Save as hereinafter provided, the Committee shall regulate the procedure for its meetings.
- (2) Meetings of the Committee shall be held on such date and at such time and place as may be determined by the Chairman:

Provided that at least one meeting shall be held in every month.

- (3) All meetings of the Committee shall be presided over by the Chairman or, in his absence, by the Member-Secretary of the Committee.
- 3. Functions of the Committee.—The functions of the Committee shall be—
  - (a) Preparation and execution of development schemes for "Beautification of Sylhet town" by the Committee or by some other agencies on its behalf.
  - (b) Any other functions assigned to it by the Government from time to time.
- Appointment of staff, etc.—The Committee may appoint such officers and staff on such terms and conditions as may be approved by the Government in the Cabinet Division.
- 5. Funds and financial powers.—(1) Tk. 10 lakh already provided and additional fund to be provided later shall be utilised by the Committee to meet charges in connection with execution of schemes for beautification of Sylhet town, including the payment of salaries and other remuneration to the officers and other employees of the Committee.
- (2) The Chairman of the Committee shall be the Drawing and Disbursing Officer of the Committee.
- (3) The funds received from the Government by the Committee shall be kept in PL account.
- (4) The Committee shall maintain its accounts as per existing Government Rules.
- (5) The accounts of the Committee shall be audited by the Comptroller and Auditor-General of Bangladesh in such a manner as he deems fit.
- (6) The Government may, from time to time, issue directions to the Committee to take such measures as it considers necessary for carrying out the purposes of this Resolution and the Committee shall comply with all such directions.

amendments shall be made in its Order No. S.R.O. 14-L/78/395/Cus., dated the 23rd January, 1978, namely:—

In the aforesaid Order,-

- (1) In Annex I, under the Head "B. PACKAGING MATERIALS USED EXCLUSIVELY IN THE MANUFACTURE OF PHARMACEUTI-CAL PRODUCTS", after serial No. (xix), the following shall be added, namely:—
  - "(xx) Amber Glass Bottles
  - (xxi) Neutral Glass Ampoules
  - (xxii) Aluminium Foil Plan (unpacked)."; and
- (2) In Annex II, under the Head "B., PACKAGING MATERIALS USED IN THE MANUFACTURE OF PHARMACEUTICAL PRODUCTS BUT NOT EXCLUSIVELY",

No. S.R.O. 56-L/78/P-S/1C-2/77/90.—In exercise of the powers conferred by the proviso to article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Bangladesh Public Service Commission as required by clause (2) of article 140 of that Constitution, is pleased to make the following further amendments in the Gazetted Officers (Directorate of Population Control and Family Planning), Recruitment Rules, 1976, namely:—

In the aforesaid Rules, in the Schedule, against Sl. No. 5, in column 1,-

- (a) for the entries in column 4, the following shall be substituted, namely:—
  - "(a) MBBS with 5 years experience; or
    - (b) Master Degree in Social Science with DPH/MPH with 7 years experience of which 5 years must be in teaching"; and
- (b) in column 5, after entry (ii), the following new entries shall be added, namely:—
- "(iii) If none is found suitable for absorption or promotion under entries (i) and (ii), the post may be filled in by transfer on deputation or promotion from Nurses with 8 years experience as

Sister Tutor or from Family Welfare Visitors with 12 years experience of which at least 8 years must be in teaching or as Field Trainer.

(iv) If none is found suitable under any of the entries, by direct recruitment.".
