এস. আর. ও নং ৫৫-আইন/৯৭-গণপ্রজাতন্ত্রী বাংলাদেশের সংবিধানের ১০৭(১) অনুচ্ছেদে প্রদত্ত ক্ষমতাবলে সুপ্রীম কোর্ট, রাষ্ট্রপতির অনুমোদনক্রমে, Civil Rules and Orders, অতঃপর উক্ত Rules বলিয়া উল্লেখিত, এর নিম্নরূপ অধিকতর সংশোধন করিলেন, যথাঃ—

(ক) উক্ত Rules এর Volume I এর rule 583 এর পর নিম্নরূপ rule 583A সন্নিবেশিত হইবে, যথাঃ—

- "583A(1) A person entitled to obtain copies of papers, records, judgements, decrees, orders, exhibits and other documents under this Chapter, may, on an application made in the forms as mentioned in sub-rule (6), obtain photostat copies of the same subject to the fulfilment of the terms and conditions and in the manner specified below.
- (2) In the event of non-availability of off-set paper or folio paper or cartridge paper, a photostat copy may be made on plain paper.
- (3) The applicant shall, within one week of the notification of the estimate by the office, supply the required paper and pay the fees under sub-rule (7).

- (4) The supply of the paper and the payment of the fees shall be entered in the relevant Register.
- (5) Where the applicant failed to supply the estimated number of papers or to pay the requisite fees within the period of one week of the notification under sub-rule (3), the application may be rejected by the Judge in-charge.
- (6) An application for a photostat copy shall be made in High Court Form No. (M) 54A and that Form shall be supplied on payment of taka one for each form in Court-fee stamp.
- (7) The following fees, payable in Court-fee stamps, are chargeable on photostat copies :—

| (iii) Authentication fee for judgement | Tk. 2.00 |

| (vi) Searching fee for other documents if the record is in the record department. | Tk. 2.00 |

Note :—Court fee stamps realised as charges for copies shall be affixed on each page of the copy.

- (8) A copy shall be supplied, not later than three days of the filing of the papers and the payment of the requisite fees.
- (9) Other provisions of this Chapter shall, if and where necessary, *mutatis mutandis*, apply for the purpose of the preparation and supply of copies under this rule.
- (10) A photostat copy shall bear the seal of the Court and the expression "Certified to be a true copy" and shall be signed in full by Head Comparing Clerk on every page.
- (11) The Certifying Officer shall append to his signature the expression "Authorised under Section 76 of the Evidence Act, 1872 (1 of 1872)".
