Dhaka, the 19th February, 1986

No. S.R.O. 61-L/86.—In exercise of the powers conferred by Section 176A of the Army Act, 1952 (XXXIX of 1952), the Government is pleased to make the following further amendment in the Army Regulations (Rules), namely:—

In the aforesaid Regulations (Rules), for regulation 413 the following shall be substituted, namely:—

“413. **Army Service Corps Conference.**—A conference of senior officers of the Army Service Corps is authorised to be convened annually at a time and place to be decided by the Director of Supply and Transport. Its duration shall not exceed four days.

(a) The following shall attend this conference:—

Director of Supply and Transport.

Inspector Army Service Corps.

Assistant Director of Supply and Transport (Supply and Transport Directorate), Army Headquarters.

Assistant Director of Supply (ST6A and ST6B, Supply and Transport Directorate), Army Headquarters.

Commandant Army Service Corps Centre and School.

Assistant Director of Supply and Transport (All Areas).

Commanding Officers of Supply and Transport Battallions including Army Supply and Transport Battalion.

Commanding Officers Base Supply Depots.

Commanding Officer Military Farm.

Officers Commanding, Station Supply Depots Class-I and Petroleum Oil and Lubricants Depot.

Commanding Officer Training Battalion Army Service Corps Centre and School.

Chief Instructor Army Service Corps School.

Deputy Assistant Adjutant and Quarter Master General (Records).

A Colonel/Lieutenant Colonel from Extra Regimental Employment (to be selected by the Director of Supply and Transport).

Deputy Assistant Director of Remount, Veterinary and Farm Corps (from Supply and Transport Directorate).

- (b) The Director of Supply and Transport shall be the Chairman of the conference, and, in his absence, the most senior officer serving in the Corps shall act as Chairman. The Chairman shall nominate an officer attending the conference to act as Secretary.

*Note :* Assistant Director Supply and Transport (All Areas) and Commanding Officers of Supply and Transport Battalions including Army Supply and Transport Battalion, with the approval of Director of Supply and Transport, may detail their representatives to attend the Conference on their behalf if they themselves due to unavoidable circumstances, are not in a position to attend."
