- No. S.R.O. 61-L/75/S-VII/1(5)/75/59.—In exercise of the power conferred by sub-section (1) of section 3 of the Shops and Establishment Act, 1965 (E. P. Act VII of 1965), the Government is pleased to suspend the operation of the provisions of sections 4, 8 and 11 of the said Act in respect of the employees of Accounts Department of the Bangladesh Electrical Industries Limited, Bham Building, Ramna, Dacca, for the period from the 31st day of January 1975 to the 15th day of February 1975 on the following conditions, namely:—
  - The employees required to work overtime shall be paid wages at double the rate of ordinary wages for working beyond the normal working hours.
