No. S.R.O. 61-L/78/400/D/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to make the following further amendment in this Ministry's Notification No. S.R.O. 108(D)Cus/73, dated the 14th June, 1973, namely:—

In the aforesaid Notification, in the Table, for the words, hyphens, inverted commas, letter and figures 'sub-head "C" of 84·41' the words, hyphens, inverted commas, letters and figures, brackets and commas "sub-head "C" of 84·41 (only the needles of sewing machines, electrically operated, requiring for their operation more than one quarter of one brake-horse power), sub-head "D" of 84·41' shall be *substituted*.

This amendment shall be deemed to have taken effect on the 26th June, 1977.
