Whereas it has been made to appear to that Mr Kanchan, son of Rustum Ali of Dighirpar, P. S. Bajitpur, Dist. Mymensingh, formerly in this Special Martial Law Court No. II, Dacca, under section/Regulation No. 148/149/448/364/302/201, B.P.C., Spl. Power Act, XIV/74;
