NOTIFICATION

Dhaka, the 9th February, 1985

No. S.R.O. 70-L/85/2-5/78-Part/E-L.—In exercise of the powers conferred by Article 94 of the Representation of the People Order, 1972 (P.O. No. 155 of 1972), the Government is pleased to make the following further amendments in the Conduct of Elections Rules, 1972, namely:—

In the aforesaid Rules,-

- (a) after rule 27, the following new rules shall be inserted, namely:—

 "27A. Account of election expenses.—(1) An election agent shall keep and maintain a register of receipts and expenditure in Form XVIIA.
 - (2) The election agent shall within thirty-five days after the publication of the name of the returned candidate under Article 19 or Article 39 submit to the Returning Officer an account of election expenses as required under Article 44C in Form XVIIA giving the account of personal expenditure referred to in clause (2) of Article 44B in Part B of that Form.
 - (3) All vouchers shall be kept alongwith the account of election expenses arranged according to the date of payment and serially numbered and such serial number shall be entered in the appropriate column of the relevant account.

(4) It shall not be necessary, while rendering account to the Returning Officer, to give particulars of the payees in regard to the items of expenditure for which receipts are not required to be obtained under clause (5) of Article 44B.

27B. Affidavits.—The affidavits referred to in clause (2) of Article 44C shall be sworn—

- (i) by a candidate who is his own election agent, in Form XVIIB;
- (ii) by a candidate who employs an election agent, in Form XVIIC; and
- (iii) by an election agent, in Form XVIID".;
- (b) after Form XVII, the following new Forms shall be inserted, namely :-
