(a) Rono Taroka (Compaign Star) (R.T.) (রণ তারকা) (3-01)

This award is conferrable on Active service in any all ranks of Bangladesh Forces rank, in other words, (MUKTI BAHINI), Both re- fighting gulars (NIYOMITO BAHINI) with scotor or Forces and citizen soldiers (GONO (Regulars). Services as BAHINI) who actively fought personnel and staff of with the Forces or sectors and Rear Headquarters and were borne on the strength of Echelon Headquarters not the Bangladesh forces for a minimum priod of 21 days operation are excluded, prior to the 16th December. 1971.

(b) Samar Padak (War Modal) (S. P.) (সমর পদক) (5-9)

This award is conferrable on all Service ranks of Bangladesh Forces Forces Headquarters and (MUKTI BAHINI), both re- Staff Echelon Headquargulars (NIYOMITO BAHINI) ters are also included. and citizen soldiers (GONO-BAHINI), who were on the strength of the Borces as well as those who fought inside Bangladesh up to the 16th December, 1971

(c) Mukti Taroka (Liberation star) (M.T.) (মজি ভারকা) (과-장)

This award is conferrable on all ranks of Bangladesh Forces against Pakistan armed who were in service with erst- forces and participation while Pakistan Armed Forces in liberation war. in both the wings of erstwhile Pakistan or anywhere outside Pakistan and defected or revolted against Pakistan and

Defection from or revolt

formed the nucleus of Bangladesh Forces up to the 17th April, 1971, and fought back with occupation forces in Bangladesh in order to offer the initial resistance.

(d) Joy Padak (J.P.) (জয় পদক) (可一円)

This award is conferrable on (Victory Medal) all ranks of Bangladesh Forces (MUKTI BAHINI), both regulars (NIYOMITO BAHINI) and chizen soldiers (GONO BAHINI) who were on the strength of Bangladesh Forece on 16th December, 1971 (Victory day), and Bangladosh Forces in Pakistan armed forces who opted for Bangladesh on first opportunity, that is, on the 10th February, 1972, or escaped from Pakistan on or before the 10th February, 1972 and subsequently were absorbed in the Bangladesh Armed Forces.

Option for Bangladesh on the 10th February. 1972 or escaped from Pakintan on or before that date.

(e) Saugbidhan Padak (Constitution Madal) (S.P.) (সংবিধান পদক) (퍼-커)

This award is conferrable on all ranks of Bangladesh Forces who were in the Strength of Bangladesh Forces and Bangladeshi forces, who opted for Bangladesh and who were in detention camps anywhere in Pakistan or escaped from Pakistan detention camps when the Government promulgated the Constitution on the 16th December, 1972 and were subsequently absorbed in the Bangladesh Armed Forces.

Option for Bangladesh and detection in detention camp.

Emphanation:— For the purposes of this regulation, "Gono Bahini" includes all members of the citizen soldiers who are recognised by the Government and who used to draw satary during the War of Liberation and whose list is available with the Army Headquarters'
