#### NOTIFICATION

### Dhaka, the 24th February, 1985

No. S.R.O. 100-L/85.—The following draft of certain further amendments to the Bangladesh Chartered Accountants Bye-laws, 1973, which the Council of the Institute of Chartered Accountants of Bangladesh proposes to make in exercise of the powers conferred by clause (1) of Article 28 of the Bangladesh Chartered Accountants Order, 1973 (P.O. No. 2 of 1973), with the approval of the Government, is published as required by clause (3) of that Article, for the information of all persons likely to be affected thereby, and notice is hereby given that the draft will be taken into consideration after thirty days of its publication in the official Gazette.

Any objection or suggestion which may be received from any person in regard to the said draft within the period specified will be considered by the Council.

#### Draft Amendments

In the aforesaid Bye-laws,-

- (1) in bye-law 68, in clause (c), sub-clauses (i) and (ii) shall be omitted;
- (2) in bye-law 69, the words and the full-stop "The probation period so served shall be treated towards the total period of articleship required to be completed under these bye-laws." shall be omitted;

- (3) in bye-law 70,-
  - (a) in clause (1) for the words "Taka fifty" the words "Taka one hundred" shall be substituted;
  - (b) after clause (1), the following new clause (IA) shall be inserted namely:—
    - "(IA) The Institute shall, with effect from first day of July 1985, register the articles on first January and first July every year and these dates shall, as the case may be, be treated to be the dates of commencement of articles irrespective of the dates of the execution of such articles.";
- (4) in bye-law 77, for clause (3), the following shall be substituted, namely:
  - "(3) A principal engaging an articled student shall, from the first day of January, 1985 pay per month minimum allowance of Taka three hundred in the first year, Taka three hundred fifty in the second year and Taka four hundred in the Third year to each such articled student.";
- (5) in bye-law 80, in clause (1), in sub-clause (a), for the words "he has passed the Intermediate and Final Examinations" the words "he has passed the Intermediate Examination and Group I and Group II of the Final Examination" shall be substituted;
- (6) after bye-law 88A, the following new bye-law 88B shall be added, namely:
  - "88B. Discretion of Council in respect of certain students.—Any person who has passed the Intermediate Examination or Group I or Group II of the Final Examination under Syllabus A or B or C may be granted exemption from such paper or papers of the Final Group I or Final Group II Examination under the revised Syllabus at the discretion of the Council.";
- (7) in bye-law 90, in clause (3), for the full-stop a colon shall be substituted and thereafter the following shall be added; namely:

"Provided that no student shall be eligible to present himself in the said examination in the event of his failure to pass the same within a period of ten years from the Ist July, 1985, or from the date of registration of articles, whichever is later.";

(8) in bye-law 93, in clause (3), for the existing provision the following shall be substituted, namely:

"Provided that a person who has passed the Intermediate Examination shall be eligible to appear in Final Group I Examination immediately after the one following the Intermediate Examination which he passed and a person who has passed Final Group I Exami-

nation shall be eligible to appear in the immediately following Final Group II Examination:

Provided further that a person who has passed the Intermediate Examination or has been exempted therefrom shall appear in the Final Group I Examination and pass the said examination for being eligible to appear in the Final Group II Examination."; and

(9) in bye-law 107, in clause (3), for the words and figure "remit a sum of Taka 5.00" the words and figure "pay a sum of Taka 50.00" shall be substituted.
