**OFFICE OF THE SUMMARY MARTIAL LAW COURT AT RAJSHAHI**  
**PROCLAMATION**

Whereas it has been made to appear to me that Alam, son of Wazed Ali of Haripur, P.S. Paba, district Rajshahi, is required for the purpose of trial in the Summary Martial Law Court at Rajshahi under Regulation 19 M.L.R.;

And whereas this Court has reason to believe that the accused (1) Alam, son of Wazed Ali of Haripur, P.S. Paba, district Rajshahi, is absconding himself to avoid appearance or arrest for the purpose;

Now, therefore, in exercise of the powers conferred by Martial Law Regulation 3(7) of Martial Law Regulation No. I of 1975, this Summary Martial Law Court at Rajshahi, do hereby direct—

- (1) Alam, son of Wazed Ali of Haripur, P.S. Paba, district Rajshahi to appear in this Court at Rajshahi on the 30th day of May, 1978 at 10 a.m., in the Martial Law Paba P.S. Case No. 19, dated the 20th November 1977 (G.R. Case No. 1226/77), failing which he will be tried *in absentia* and his property may be forfeited to the Government.
