Dacca, the 31st March 1977.

No. S. R. O. 111-L/77.—In exercise of the powers conferred by the proviso to article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Public Service (First) Commission as required by clause (2) of article 140 of that Constitution, is pleased to make the following further amendment in the Bangladesh Food Administration Service Rules, 1959, namely:—

Amendments

In the aforesaid Rules, in the Schedule, after item 28 in column 1 and the entries relating thereto in columns 2 and 3, the following shall be added, namely:—

- "29. Chemist
- (i) By promotion from the post of Assistant Chemist, and
- (i) Must have at least 5 years' experience as Assistant Chemist.
- (ii) No age limit.
- (ii) if no suitable candidate is available for promotion, by direct recruitment through Bangladesh Public Service (First) Commission.
- (i) Must hold a 2nd class M.Sc. degree with Honnours (2nd class) in Organic Chemistry or Bio-Chemistry. Preference will be given to those having 1st class degree in M.Sc.

- (ii) Must have at least 3 years* experience of analysis in a Laboratory in foodstuff, Vitamins and matters relating thereto.
- (iii) Age limit-Not exceeding 28 years.

- (i) Must hold either high 2nd class B.Sc. (Honours) degree with Organic Chemistry or Bio-Chemistry, B.Sc. degree (with or first Division) with Chemistry as one of the subjects.
- (ii) Must have at least 3 years' experience of analysis in a Laboratory in foodstuff, Vitamins and matters relating thereto.
- (iii) Age limit-Not exceeding 27 years.

- (i) Merit-cum-Seniority.

Dinajpur, is required for the purpose of an enquiry and other proceedings for SGR 3/77 for an offence punishable under 156(8)C Act and 19 of the Martial Law Regulations, 1975;
