#### NOTIFICATION

#### Dhaka, the 4th March, 1985

No. S.R.O. 113-L/85/S-XI/3R-1/85/16.—In exercise of the powers conferred by section 146 of the Paurashava Ordinance, 1977 (XXVI of 1977), and in supersession of the Paurashava (Payment of Honorarium to Chairmen and Commissioners) Rules, 1979, the Government is pleased to make the following rules, namely:—

## THE PAURASHAVA (PAYMENT OF HONORARIUM TO CHAIRMEN AND COMMISSIONERS) RULES, 1985.

- 1. Short title.—These rules may be called The Paurashava (Payment of Honorarium to Chairmen and Commissioners) Rules, 1985.
- 2. Payment of honorarium.—(1) The Chairman shall, in the case of a Paurashava having an annual income of—
  - (a) Taka thirty lacs and above,

to like the Vita date of the

- (b) Taka five lacs and above but less than Taka thirty lacs, or
- (c) Less than Taka five lacs, be paid an honorarium of Taka one thousand two hundred and fifty, Taka one thousand and Taka seven hundred and fifty per month respectively with effect from the date of assumption of his office.
- (2) A commissioner shall, in the case of a Paurashava having such annual income as has been specified in clause (a), (b) or (c) of sub-rule (1), be paid an honorarium of Taka five hundred, Taka four hundred and Taka three hundred per month respectively with effect from the date of assumption of his office.
- (3) No Chairman or Commissioner of a Paurashava falling under clause (b) or (c) of sub-rule (1) shall be paid an honorarium in excess of the amount specified for him under this rule without the prior approval of the Government even though the income of the Paurashava during its term exceeds the specified limit.
- 3. Drawal of honorarium.—The Chairman and Commissioners shall draw the amount of honorarium from the concerned Paurashava Fund.
