No. S.R.O. 114-L/78/411/D/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to make the following further amendments in this Ministry's Notification No. S.R.O. 30/D/Cus/72, dated the 30th June, 1972, namely:—

In the aforesaid Notification, in the Table,-

(a) after Heading No. 28.56 in column (1) and the entries relating thereto in columns (2) and (3) the following new Heading No. in column (1) and the entries relating thereto in columns (2) and (3) shall be inserted namely:—

Dacca, the 24th May, 1978.

- No. S.R.O. 116-L/78/413/D/Cus.—In exercise of the powers conferred by clause (c) of section 21 of the Customs Act, 1969 (IV cf 1969), and in supersession of the S.R.O. 175(R)/68, dated the 9th October, 1968, the National Board of Revenue is pleased to authorise repayment of the whole of the customsduties paid on the importation of raw materials and components, excluding M. S. Plates, falling under sub-head B of Heading No. 73.13 of the First Schedule to the Tariff Act, 1934 (XXXII cf 1934), used in the building, fitting, repairing or refitting of ships, boats, floating structures and other vessels, whether self-propelled or not, designed primarily for the conveyance of persons or goods or both persons and goods by sea or by inland navigation by private shipyards, and in the case of importation of M. S. plates by such importers, the repayment shall be made to the extent as is in excess of 10% ad valorem, subject to the following conditions, namely:—
 - (i) the importers have been approved by the National Board of Revenue as licenced manufacturers under the proviso to item 31 of the Ministry of Finance (Revenue Division) Notification (Sales Tax) No. 7, dated the 27th June, 1951;
 - (ii) the importers of the raw materials and components shall declare, at the time of import, that the materials and components have been imported for use in the building or fitting, repairing, or refitting of ships, boats, floating structures or other vessels whether self-propelled or not, designed primarily for the conveyance of persons or goods or both persons and goods by sea or by inland navigation;
 - (iii) the declaration referred to in paragraph (ii) shall be submitted to the office of the Collector of Customs; and
 - (iv) the importer shall, within 90 days of the date of clearance, claim from the Collector of Customs refund of the customs-duties paid on the imported materials and components, the claim being supported by a certificate in the form set out below issued by any one of the following, namely:—
 - (1) Director General, Department of Industries, Dacca;
 - (2) Deputy Director General, Department of Industies, Dacca; or
 - (3) Director of Industries, Department of Industries.

MINISTRY OF COMMERCE NOTIFICATION Dacca, the 24th May 1978.

No. S.R.O. 119-L/78.—In exercise of the powers conferred by proviso to article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Bangladesh Public Service Commission as required by clause (2) of article 140 of that Constitution, is pleased to make the following rules, namely:—

THE GAZETTED CLASS I OFFICERS (DIRECTORATE OF COAL) RECRUITMENT RULES, 1978.

1. Short title.—These rules may be called the Gazetted Class I Officers (Directorate of Coal) Recruitment Rules, 1978.

- 2. Definition.- In these rules, unless there is anything repugnant in the subject or context,-
 - (a) "appointing authority" means the Government and includes, in relation to any specified post or class of such sposts, any officer authorised by the Government to make appointment to such post or class of posts;
 - (b) "Commission" means the Bangladesh Public Service Commission;
 - (c) "Probationer" means a person appointed on probation to a specified post;
 - (d) "requisite qualification", in relation to a specified post, means the qualification laid down in the Schedule in relation to that post;
 - (e) "recognised University" means a University established by or under any law for the time being in force and includes any other University declared by the Government, after consultation with the Commission, to be a recognized University for the purposes of these rules;
 - (f) "Schedule" means the Schedule annexed to these rules; and
 - (g) "specified post" means a post specified in the Schedule.
- 3. Procedure for recruitment. -(1) Subject to the provisions of the schedule, appointment to a specified post shall be made, -
 - (a) by transfer or deputation; or
 - (b) by promotion; or
 - (c) by direct recruitment.
- (2) No person shall be appointed to a specified post unless he has the requisite qualification, and in the case of direct recruitment, he is also within the age limit specified in the Schedule.
- 4. Appointment by direct recruitment.—(1) No appointment to a specified post by direct recruitment shall be made except upon the recommendation of the Commission.
- (2) No person shall be eligible for appointment to a specified post by direct recruitment, if he—
 - (a) is not a citizen of Bangladesh, or a permanent resident of, or domiciled in Bangladesh; and
 - (b) is married to or has entered into a promise of marriage with, a person who is not a citizen of Bangladesh.

- (3) No appointment to a specified post by direct recruitment shall be made until-
 - (a) the person selected for appointment is certified by a Medical Board set up for the purpose by the Director of Health Services to be medically fit for such appointment and that he does not suffer from any such organic defect as is likely to interfere with the discharge of the duties of the sepecified post; and
 - (b) the antecedents of the person so selected have been verified through the appropriate agencies and found to be such as do not render him unfit for appointment in the service of the Republic.
- 5. Appointment by promotion.—(1) Subject to the Schedule, appointment by promotion shall be made after considering the recommendations of such departmental promotion committee as the Government may set up for the purpose.
- (2) A person shall not be eligible for appointment by promotion to a specified post if he has not been confirmed in any post on the ground of unsatisfactory service records.
- 6. Probation. —(1) Persons selected for appointment to a specified post against a substantive vacancy shall be appointed on probation,
 - (a) in the case of direct recruitment, for a period of two years from the date of substantive appointment; and
 - (b) in the case of promotion, for a period of one year from the date of such appointment;

Provided that the appointing authority may, for reasons to be recorded in writing, extend the period of probation in the case of any person by a period or periods so that the extended period does not exceed two years in the aggregate.

- (2) After the completion of the period of probation, including the extended period, if any, the appointing authority,—
 - (a) if it is satisfied that the conduct and work of the probationer during the period of his probation has been satisfactory, shall, subject to the provision of sub-rule (3), confirm him; and
 - (b) if it is of opinion that the conduct and work of the probationer during that period was not satisfactory, may,—
 - (i) in the case of the direct recruitment, terminate his service; and
 - (ii) in the case of promotion, revert him to the post from which he was promoted.
- (3) A probationer shall not be confirmed in the specified post unless he has passed such departmental examination as the Government may, from time to time, direct.
