No. S.R.O. 117-L/75.—In exercise of the powers conferred by section 5 of the Opium Act, 1878 (I of 1878), the Government is pleased to make the following further amendment in the Rules published under notification No. 562-S.R., dated the 2nd March 1918, namely:—

In the aforesaid Rules, for rule 19A the following shall be ubstituted,

"19A. Excise Opium shall be sold by retail vendors thereof at the retail selling price specified below:—

Area.

Retail selling price.

- (a) Municipal areas of Dacca and Narayanganj in the district of Dacca, Chandpur in the district of Comilla, Chittagong and the industrial area of Pahartali in the district of Chittagong and Khulna in the district of Khulna.
- (b) Areas other than these mentioned in clause (a) 991.00 12.40
- The price specified by this notification shall be applicable only to excise opium imported from India in January 1975.

No. S.R.O. 118-L/75.—In exercise of the powers conferred by sub-section (I) of section 27 of the Finance Act, 1974 (XLIV of 1974), read with section 21 thereof, the Government is pleased to make the following rules, namely:—

THE BETTERMENT TAX RULES, 1975

- 1. Short title.-These rules may be called the Betterment Tax Rules, 1975.
- 2. Definitions.—In these rules, unless there is anything repugnant in the subject or context,—
 - (a) "Act" means the Finance Act, 1974 (XLIV of 1974);
 - (b) "assessee" means a person who is carrying on, for the time being, any business or trade in the area specified by the Government by notification in the official Gazette under sub-section (I) of section 21 of the Act, and includes a person in respect of whom any proceeding under these rules has been taken for the determination of the tax payable by him or of the amount of refund due to him;
 - (c) "Assessing Officer" means a Taxation Officer appointed under section 21 of the Agricultural Income-tax Act, 1944 (Ben. Act IV of 1944);
 - (d) "Deputy Director" means the Deputy Director of Taxation appointed under section 21 of the Agricultural Income-tax Act, 1944 (Ben. Act IV of 1944);
 - (e) "Director" means the Director of Taxation of Excise appointed under section 21 of the Agricultural Income-tax Act, 1944 (Ben. Act IV of 1944);
 - (f) "form" means a form appended to these rules;
 - (g) "month" means an English calendar month;
 - (h) "person" includes a Hindu undivided family, a firm, an association of person, a company and a local authority;
 - (i) "return" means a return required to be submitted under sub-rule (I) of rule 5 or rule 6 of these rules;
 - (j) "tax" means the betterment tax leviable under sub-section (I) of section 21 of the Act;
 - (k) "treasury" means the Government Treasury or Sub-Treasury and includes the Bangladesh Bank or a branch thereof and any scheduled bank or a branch thereof which is authorised to transact treasury functions;
 - (I) "year" means the financial year, and "half-year" means the six months from the first day of July to thirty-first day of December and from the first day of January to thirtieth day of June,

- 3. Jurisdiction of authorities.—(1) The Deputy Director shall, in respect of the whole of Bangladesh or such area as may be specified by the Government by notification in the official Gazette for the purpose of agricultural income-tax, exercise the powers conferred and perform the duties imposed on him by these rules.
- (2) The Assessing Officer shall, in respect of such area as may be specified for the Taxation Officer by the Government by notification in the official Gazette for the purpose of agricultural income-tax, exercise the powers conferred and perform the duties imposed on him by these rules.
- 4. Calculation of months.—In calculating months for the determination of tax, a part of a month less than 15 days shall be ignored and 15 days or more shall be treated as one month.
- 5. Return.—(1) Every assessee shall, within thirty days of the end of each half-year, submit to the Assessing Officer a return in form B.T.-I.
- (2) Every assessee shall pay, under the head "XIII—Other taxes and duties—Betterment Tax," on or before the date on which he is required to submit the return under sub-rule (I), the amount of tax payable by him on the basis of the said return.
- 6. Notice for return,—In the case of any person who, in the opinion of of the Assessing Officer, is lie ble to submit the return, the Assessing Officer may serve a notice upon him requiring him to furnish the return in form B.T.-I within such period, not being less than 15 days, as may be specified in the notice.
- 7. Assessment,—(I) If the Assessing Officer is satisfied that the return submitted under sub-rule (I) of rule 5 or 6 is correct and complete, he shall make an assessment on the basis thereof and determine the amount of tax payable after giving credit for the tax paid.
- (2) If the Assessing Officer is not so satisfied, he may, after calling for such further particulars and information as he may require, determine the tax payable.
- (3) If the return has not been submitted under sub-rule (1) of rule 5 or rule 6 or the particulars and information called for under sub-rule (2) have not been furnished, the Assessing Officer shall make an assessment to the best of his judgement.
- (4) No order of assessment under this rule shall be made after expiry of five years from the end of the year for which the tax was first assessable.
- (5) Nothing contained in this rule shall prevent an Assessing Officer from determining in a single assessment the tax payable for the whole year.
- 8. Tax escaping assessment, etc.—If for any reason, for any year, no assessment of tax has been made or tax has been under-assessed or has been assessed at a rate lower than the rate specified by notification under section 21 of the Act or an excess refund has been allowed, the Assessing Officer may, at any time within five years from the end of the year, assess or re-assess the tax payable or determine the refund allowable after serving notice on the assessee and making such enquiry as he may consider necessary:

Provided that the time limit specified in this rule shall not apply in a case in which the Assessing Officer has reason to believe that an assessee has concealed the particulars of tax or has deliberately furnished inaccurate particulars thereof or has not submitted any return for any year, and the Assessing Officer may in such a case serve a notice on the assessee at any time and assess or re-assess the tax or as the case may be, determine the refund within one year from the date of service of such notice;

Provided further that, notwithstanding anything contained in this rule, where an order of assessment has been set aside by an order made under rule 11 or 12, a fresh assessment shall be made at any time before the expiry of four years from the end of the year in which the order under rule 11 or 12 setting aside the order of the Assessing Officer is received by the Assessing Officer.

- 9. Notice of demand.—When any tax or penalty is due in consequence of any order passed under rules 7, 8 or 10, the Assessing Officer shall serve upon the assessee liable to pay such tax or penalty a notice of demand in form B.T.-II specifying the sum payable. If, as a result of assessment, it is found that any amount has been paid in excess of the tax due, the excess amount shall be shown refundable in the notice of demand.
- 10. Penalty.—If any assessee has, without reasonable cause, failed to pay the tax or paid less than what is due under rub-rule (2) of rule 5 or failed to pay the tax as demanded under rule 9, the Assessing Officer may impose a penalty on the assessee not exceeding the amount of the tax payable:

Provided that no penalty shall be imposed unless the assessee has been given an opportunity of being heard.

- 11. Appeal.—(1) An assessee aggrieved by an order of assessment of tax under rule 7 or assessment or reassessment of tax or determination of refund under rule 8 or an order of penalty under rule 10 may prefer an appeal to the Deputy Director.
- (2) Every memorandum of appeal shall be presented within thirty days from the date of receipt of notice of demand:

Provided that an appeal may be admitted after this period if the Deputy Director is satisfied that the appellant had sufficient cause for his inability to file the appeal within this period.

- (3) Every memorandum of appeal shall be accompanied by a certified copy of the order appealed against.
- (4) The Deputy Director may, after giving the appellant a reasonable opportunity of being heard, pass such order on the appeal as he may think fit:

Provided that the Deputy Director shall not enhance an assessment unless the appellant has had a reasonable opportunity of showing cause against such enhancement;

Provided further that at the time of hearing of an appeal against an order of the Assessing Officer, the Assessing Officer shall have the right to be heard either in person or through a representative.

12. Revision—The Director may, on application by an assessee for revision of an order passed by a Deputy Director or by an Assessing Officer made with n ninety days from the date of receipt of the order or within such further period as the Director may consider fit to allow on being satisfied that the assessee was prevented by sufficient cause from making the application within that period, call for the records of proceeding in which such order was passed; and, on receipt of the records, may make such enquiry or cause such enquiry to be made, and may, subject to the provisions of the Act and these rules, pass such order thereon, not being an order prejudicial to the assessee, as he thinks fit:

Provided that the Director shall not revise any order under this rule in a case where—

- (a) the time within which an appeal may be made has not expired; or
- (b) the right of appeal has not been waived by the assessee; or
- (c) an appeal against the order of the assessing officer has been preferred to the Deputy Director and pending before him.

Explanation—An order by the Director rejecting the prayer for revision of the order of the Deputy Director or Assessing Officer shall not be deemed to be an order prejudicial to the assessee.

13. Rectification of mistakes.—The Director or the Deputy Director may, at any time within four years from the date of any order passed by him in revision or in appeal, as the case may be, and the Assessing Officer may, at any time within four years from the date of any order, including an order for refund, passed by him, on application or on his own motion, rectify any mistake apparent from the records relating to the revision, appeal, assessment or refund, as the case may be:

Provided that no such rectification shall be made having the effect of enhancing an assessment or reducing a refund unless the Director the Deputy Director or the Assessing Officer, as the csse may be, has given notice to the assessee of his intention to do so and has allowed him a reasonable opportunity of being heard.

- 14. Power to inspect.—The Assessing Officer or and officer authorised by him in this behalf, may inspect any register, paper, document and premises of any person liable to pay the tax and may collect therefrom such particulars as are considered necessary for the purpose of these rules.
- 15. Refund.—(1) The Assessing Officer shall make refund of tax or penalty as shown in the notice of demand under rule 9 within ninety days from the date of issue of the said notice.
- (2) In cases where no refund has been determined by the Assessing Officer but the assessee claims to have paid tax in excess of what is due from him and feels that a refund is due to him shall submit an application in writing to the Assessing Officer claiming such refund along with a return for the relevant year in form B.T.-I duly filled in within three years from the end of the year for which the refund is due.

No. S.R.O-123-L/75/S-IV/E-52/74/148.—In exercise of the powers conferred by Article 9 of the Bangladesh Abandoned Children (Special Provisions) Order, 1972 (P.O. No. 124 of 1972), the Government is pleased to make the following rules, namely:—

1. Short title.—These rules may be called the Bangladesh Abandoned Children (Special Provisions) Rules, 1975.

- 2. Definitions.—In these rules, unless there is anything repugnant in the subject or context,—
 - (a) "Form" means a form annexed to these rules;
 - (b) "Order" means the Bangladesh Abandoned Children (Special Provisions) Order, 1972 (P.O. No. 124 of 1972);
 - (c) "Processing agency" means a person or an organisation legally authorised by an adoption agency and duly endrosed by the Government Agency of the country concerned to act and take actions necessary in connection with the matter of adoption for and on behalf of such adoption agency.
- 3. Procedure for application.—(I) An adoption agency desirous of adopting an abandoned child shall make an application in Form 'A' to the Director of Social Welfare, accompanied by the documents mentioned in the instructions contained in the Form and the Director may call for such other documents or information as he may deem fit.
- (2) The Director of Social Welfare may, for reasons to be recorded in writing, waive submission of any of the documents referred to in the instructions mentioned in Form 'A'.
- (3) If there is more than one application for an abandoned child, the Director of Social Welfare shall dispose of the applications on the "first come first served basis".
- 4. Disqualification.—If any adoption agency or processing agency takes over an abandoned child in its custody before the abandoned child is delivered to the adoption agency or, as the case may be, the processing agency by the statutory guardian for the purpose of adoption on execution of an instrument in Form 'B' the adoption agency or, as the case may be, the processing agency shall stand disqualified from being considered as such agency, unless the Director of Social Welfare, for reasons to be recorded in writing, decides otherwise.
- 5. Enquiry.—(1) On receipt of an application under rule 3, the Director of Social Welfare may make or cause to be made such enquiries in such manner as he may deem fit and proper about the competence or otherwise of the adoption agency or the processing agency to adopt an abandoned child.
- (2) In order to enable the Government to form an opinion whether a child is an abandoned child within the meaning of clause (d) of Article 2 of the Order, the Director of Social Welfare shall make enquiries—
 - (a) in the case of a child whose mother, father or any other legal guardian is present, whether such child is being voluntarily and wilfully surrendered for adoption; and
 - (b) in any other case, by advertisement in the press whether there is any claimant with respect to the child;
 - and may make such further enquiries as he may deem fit.
- (3) The Director of Social Welfare shall within three weeks complete the enquiries as required under sub-rule (2) and submit the enquiry report immediately to the Government.

- 6. On receipt of the enquiry report under sub-rule (3) of rule 5, the Government shall express an opinion with respect to such child as required by clause (d) of Article 2 of the Order.
- 7. The statutory guardian may, after being satisfied about the fulfilment of the provisions of the Order and the rules made thereunder, deliver the abandoned child to the adoption agency or the processing agency, as the case may be, on execution of an instrument in Form 'B'.
