No. S. R. O. 122-L/78.—In exercise of the powers conferred by sub-sections (1) and (2) of section 14 of the Code of Criminal Procedure, 1898 (Act V of 1898), read with section 39 and sub-section (2) of section 190 of the said Code, the Government is pleased to—

- (a) appoint the Chairman of the Comilla, Brahmanbaria and Chandpur Pourashavas to be honorary Special Magistrates until further orders:
- (b) confer upon the Special Magistrates appointed under clause (a) the powers of a Magistrate of the second class in respect of offences specified in the Second Schedule to the Pourashava Ordinance, 1977 (Ord. XXVI of 1977), occurring within the limits of their respective Pourashavas; and
- (c) empower the Special Magistrates appointed under clause (a) to take cognizance of offences which they may try under clause (a) or (b) of sub-section (1) of section 190 of the said Code.

- (2) Ruhul Amin, son of Muslim Mia of Sonaicha,

all of P.S. 14 Gram, Dist. Comilla, accused in SGR Case No. 133/77, u/s. 156(8)CA and 19 MLR. arising out of Chauddagram P.S. Case No. 3, dated the 8th October 1977 to appear in this Court at Comilla within 7 days of publication of this Proclamation failing which they will be tried in absentia and their properties may be forfeited to the Government.
