NOTIFICATION

No. 217-Min/HA.(Police-IV).—Government have decided to set up with immediate effect, Advisory Committees on Law and Order at the National, District, Subdivisional and Thana levels with a view to enlisting fuller cooperation and participation of the people with the law enforcing agencies in suppressing crime in the country.

The terms of reference and membership of the different Committees are given below:—

TERMS OF REFERENCE

(A) National Advisory Committee:

- (1) The Committee will review the overall law and order situation of the country and suggest measures for improvement.
- (2) It will advise Government on ways and means of enlisting people's support for crime control and creating a happy law and order situation.
- (3) It will advise Government as to how the spirit of service to the Community can be best imbibed by the law-enforcing agencies.
- (4) It will consider and recommend special measures to deal with particular types of crimes or crimes in particular areas, as the case may be.
- (5) It will bring to the notice of Government difficulties and handicaps being faced by the law-enforcing agencies in carrying out their duties.

- (6) It will bring to the notice of Government any gross irregularities or excesses committed by law-enforcing agencies and suggest effective remedial measures.
- (7) It may invite, receive and consider suggestions from the public on improving law and order administration and the efficiency of the crime control measures.
- (8) It will advise Government on appropriate publicity and education on crime control and law and order.
- (9) The Committee will perform such other functions as may be assigned by Government from time to time.
- (10) The Committee will meet at least once in every three months.

(B) Territorial Committees:

- (1) The Committees will review the law and order situation of their respective area.
- (2) They will suggest measures for improvement of the law and order situation in their areas to the appropriate authorities.
- (3) They will bring to the notice of local administration any gross irregularity or excess committed by the law-enforcing agencies operating within the locality and suggest corrective measures.
- (4) They will endeavour to enlist people's support and participation to improve law and order situation of the area through necessary publicity, propaganda, education and general mobilization and shall make every possible effort to promote co-operation in the national interest among the forces and the people.
- (5) They will suggest measures necessary for removal of operational difficulties and handicaps of the law-enforcing agencies.
- (6) The committees will meet at least once in three months preferably at different places and try to meet as many people as possible during and after their meetings. The Thana level meetings may be open to the public if the Committees so desire.
