Dacca, the 2nd June, 1978.

No. S.R.O. 125-L/78.—In exercise of the powers conferred by sub-sections (1) and (2) of section 14 of the Code of Criminal Procedure, 1898 (Act V of 1898), read with section 39 and sub-section (2) of section 190 of the said Code, the Government is pleased to—

- (a) appoint the Chairmen of the Jhenidah, Kotchandpur, Moheshpur, Magura, Narail and Kalia Pourashavas to be honorary Special Magistrates until further orders;
- (b) confer upon the Special Magistrates appointed under clause (a) the powers of a Magistrate of the second class in respect of offences specified in the Second Schedule to the Pourashava Ordinance, 1977 (Ord. XXVI of 1977), occurring within the limits of their respective Pourashavas; and
- (c) empower the Special Magistrates appointed under clause (a) to take cognizance of offences which they may try under clause (a) or (b) of sub-section (1) of section 190 of the said Code.

No. S.R.O. 126-L/78.—In exercise of the powers conferred by sub-sections (1) and (2) of section 14 of the Code of Criminal Procedure, 1898 (Act V of 1898), read with section 39 and sub-section (2) of section 190 of the said Code, the Government is pleased to—

- (a) appoint the elected Commissioners of the Jhenidah, Kotchandpur, Moheshpur, Magura, Narail and Kalia Pourashavas to be honorary Special Magistrates until further orders;
- (b) confer upon the Special Magistrates appointed under clause (a) the powers of a Magistrate of the third class in respect of offences specified in the Second Schedule to the Pourashava Ordinance, 1977 (Ord. XXVI of 1977), occurring within the limits of their respective Pourashavas; and
- (c) empower the Special Magistrates appointed under clause (a) to take cognizance of offences which they may try under clause (a) or (b) of sub-section (1) of section 190 of the said Code.

NOTIFICATIONS

Special M. L. Case No. 137/77
