এস, আর, ও, নং ১২৭-আইন/১২—Bangladesh Banks (Nationalisation) Order, 1972 (P.O. No. 26 of 1972) এর Article 26 এ প্রদত্ত ক্ষমতাবলে সেনালী ব্যাংক পরিচালক-পর্ষদ, সরকারের প্রান্মোদনক্রম, Sonali Bank General Regulations, 1974 এ নিন্দরেশ অধিকতর সংশোধন করিল, যথাঃ—

উদ্ভ Regulations এর regulation 6 এর পরিবর্তে নিম্নর্প regulation প্রতিস্থাপিত ইইবে, যথাঃ—

- "6. Remuneration of Directors.—(1) The Chairman shall be paid a honorarium of Taka two thousand and five hundred per month and such fee and allowances as admissible to a Director under sub-regulations (2), (3) and (4).
 - (2) A Director,-
 - (a) except a person who is a Government Official, shall be paid Taka five hundred as fee for attending each meeting of the Board or its Committee;

(b) Who is a Government Official, shall be paid such fee for attending meeting of the Board or its committee as determined by the Government, from time to time.

(3) A Director,-

- (a) except a person who is Government Official, shall be paid-
 - (i) one first class rail or steamer fare or economy class air passage for each journey; or
 - (ii) road milage at the rate of Taka one per mile or any part thereof for the journey performed by road; or
 - (iii) travelling allowances which is considered economical to the Bank in a case where journey has been undertaken by road but the destination is connected partly by air or partly by steamer; or
 - (iv) where the journey is performed by a route which is not the shortest but is cheaper than the shortest, the travelling allowance for the route actually used; and
 - (v) diem allowance Taka five hundred for the actual days of journey, meeting attended and subject to a maximum of three days halt, if actually made out of the station of his residence;
- (a) who is a Government Official, shall be paid travelling allowance and diem allowance according to the Government rules applicable to him.

for attending meeting of the Board or its Committee, or to visit any place on behalf of the Board or its Committee.

(4) A Director, except a person who is a Government Official, shall be paid such travelling allowance and diem allowance for the journey and halt outside Bangladesh as determined by the Government."
