No. S.R.O. 135-L/76.—In exercise of the powers conferred by section 10 of the Censorship of Films Act, 1963 (XVIII of 1963), the Government is pleased to make the following amendments in the Bangladesh Censorship of Films Rules, 1972, namely:—

In the aforesaid Rules,—

(a) in rule 14, in sub-rule (5),—

(i) in clause (a), for the table the following shall be *substituted*, namely:—

Size of film.	Length of film.	Scale of fees.
“(1) 35mm	(i) Where the length of the film does not exceed 3,000 feet.	Taka 50 per 1,000 feet or a fraction thereof.

- (ii) Where the length of the film exceeds 3,000 feet but does not exceed 13,000 feet. Taka 150 *plus* Taka 100 per 1,000 feet or a fraction thereof exceeding 3,000 feet.
- (iii) Where the length of the film exceeds 13,000 feet. Taka 1,150 *plus* Taka 1,000 per 100 feet or a fraction thereof exceeding 13,000 feet.
- (2) 16mm (i) Where the length of the film does not exceed 1,200 feet. Taka 50 per 400 feet or a fraction thereof.
- (ii) Where the length of the film exceeds 1,200 feet. Taka 150 *plus* Taka 100 per 400 feet or a fraction thereof exceeding 1,200 feet", and
- (ii) in clause (b), in the table, in the fourth column, under the heading "Scale of fees" against items (1) and (2) in the first column, for the figures "25", "250", "20" and "50" the figures "50", "500", "40" and "100" shall respectively be *substituted*; and
- (b) in rule 25, for the word "two" the word "ten" shall be *substituted*.

## MINISTRY OF INDUSTRIES

No. NID/S-VII(L)/552/76-1915.—The Government of the People's Republic of Bangladesh is pleased to determine the wages, fringe benefits, leave and holidays of the casual workers attached to Sugar Cane Farms of the Sugar Mills of the Bangladesh Sugar Mills Corporation as follows:—

1. **Wages.**—The casual workers shall be entitled to the following wages on daily rate basis:—

- (a) Heavy job workers: .. Tk. 7.00 only per working day.
- (b) Light job workers: .. (i) Male worker Tk. 6.00 per working day.
- (ii) Old Male/Female and adolescent worker Tk. 5.00 per working day.  
The light job workers will get the above specified wages wherever they work in the Farm.
- (c) Very light job workers: .. Tk. 1.25 to 1.50 per working day.

2. **Fringe Benefits.**—(a) The system of allowing subsidised ration in the various Farms shall henceforth be withdrawn. Ration will, however, be allowed to them at Government rates as and when available from Government rationing quota.

(b) For seasonal disease, primary medical aid will be allowed and this can be extended to the family of the workers who are residing in the premises of the Management.

(c) For accidents the provision of the Workmen's Compensation Act will be followed.

(d) Maternity benefit up to two childrens be allowed to the female workers.

3. **Leave and Holidays.**—The following leave and holidays shall be allowed to the casual workers:—

(a) 10 days Festival Holidays may be allowed with pay to the Farm workers if they remain present preceding and following that Festival Holidays.

(b) If any worker continuously works 240 days in a year, he may be allowed 1 (one) day annual leave for every 18 days works actually performed.

The nature of the employment will remain unaltered. Schedule of workers as at 1(a), (b) and (c) is enclosed. For any designation left the management concerned will fix them suitably.

This order shall come into effect immediately.
