In inviting attention to this office Public Notice No. 20(77)/Import, dated 4th April 1977, it is hereby notified for the information of all concerned that the last date for opening Letter of Credit and shipment of goods against licences issued under the West German Commodity Loan for DM 50(m), dated 2nd November 1976 (AL 76 65 771) has been extended up to 30th June 1977 and 30th September 1977 respectively.



2. Since Letters of Credit under the said loan shall be opened on first-come-first-served basis, the importers concerned are advised in their own interest to open L/C against licences issued under the abovementioned loan quickly. It is also brought to the notice of the concerned importers that if the fund under this loan is exhausted due to the negligence of the importers in opening Letters of Credit immediately, the authority concerned shall not be held responsible/liable for the inconvenience caused to the importers for exhaustion of fund.

R. O. 214-L/75/10/75-Excise, dated the 23rd June, 1975, namely:—

In the aforesaid Notification, in the Table,—

for Sl. No. 1 in column 1 and the entries relating thereto in columns 2, 3 and 4, the following shall be substituted.

“1. Item No. 3(2)(i) of Tea—

the First Schedule.

Tea packed in any kind of container, package or bag on which weight and retail price are legibly, prominently and indelibly printed and if such retail price—

**Dacca, the 28th April, 1977.**

**No. S. R. O. 137-L/77.**—In exercise of the powers conferred by the proviso to Article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Bangladesh Public Service (First) Commission as required by clause (2) of Article 140 of the Constitution, is pleased to make the following rules, namely:—

**THE AUDIT BUREAU OF CIRCULATION (GAZETTED OFFICERS)  
RECRUITMENT RULES, 1977.**

1. **Short title.**—These rules may be called the Audit Bureau of Circulation (Gazetted Officers) Recruitment Rules, 1977.
2. **Definitions.**—In these rules, unless the context otherwise requires—
  - (a) “appointing authority” means the Government and includes in relation to a specified post, any officer authorised by Government to make appointment to the post;
  - (b) “Bureau” means the Audit Bureau of Circulation of the Ministry;
  - (c) “Commission” means the Bangladesh Public Service (First) Commission;
  - (d) “Ministry” means the Ministry of Information and Broadcasting;
  - (e) “Probationer” means a person appointed on probation to a specified post;
  - (f) “recognised University” means a University established by or under any law for the time being in force and includes any other University declared by Government, after consultation with the Commission, to be a recognised University for the purposes of these rules;
  - (g) “specified post” means a post specified in the Schedule; and
  - (h) “Schedule” means the Schedule to these rules.
3. **Procedure of recruitment.**—(1) Subject to the provision of the Schedule, appointment to a specified post shall be made—
  - (a) by promotion; or
  - (b) by transfer of service from the Ministry and its attached or subordinate offices; or
  - (c) by direct recruitment.

(2) In the case of direct recruitment, no person shall be appointed to a specified post unless he has requisite qualification and is within the age limit laid down in the schedule.



**4. Appointment.**—(1) No appointment to a specified post by direct recruitment shall be made by the appointing authority except upon the recommendation of the Commission.

(2) No person shall be eligible for appointment to a specified post, if he—

- (a) is not a citizen of Bangladesh, or a permanent resident of, or domiciled in, Bangladesh;
- (b) is married to, or has entered into a promise of marriage with, a person who is not a citizen of Bangladesh.

(3) No appointment to a specified post by direct recruitment shall be made until—

- (a) the person selected for appointment is certified by a Medical Board set up for the purpose by the Government to be medically fit for such appointment and that he does not suffer from any such organic defect as is likely to interfere with the discharge of the duties of the specified post;
- (b) the antecedents of the person so selected have been verified through appropriate agencies and found to be such as do not render him unfit for appointment in the service of the Republic.

(4) No person shall be recommended by the Commission for appointment to a specified post unless—

- (a) he has applied in such form accompanied by such fee and before such date, as is notified by the Commission while inviting applications for the specified post; and
- (b) in the case of a person already in Government service or in the service of a local authority, he has applied through his official superior.

(5) Appointment by promotion or by transfer of service to a specified post shall be made by the appointing authority after considering the records of service by the Departmental Promotion Committee constituted by the Government in this behalf.

**5. Probation.**—(1) Persons selected for appointment to a specified post otherwise than by transfer of service against a substantive vacancy shall be appointed on probation—

- (a) in the case of direct recruitment, for a period of two years from the date of substantive appointment; and
- (b) in the case of promotion, for a period of one year from the date of such appointment:

Provided that the appointing authority may, for reasons to be recorded in writing, extend the period of probation by a period or periods so that the extended period does not exceed two years in the aggregate.

(2) After the completion of the period of probation including the extended period, if any, the appointing authority—

- (a) if it is satisfied that the conduct and work of the probationer during his period of probation has been satisfactory, shall confirm him; and
- (b) if it is of opinion that the conduct and work of the probationer during that period was not satisfactory, may, in the case of direct recruitment, terminate his service and, in the case of promotion, revert him to the post from which he was promoted.
