 (5) Upazila Nirbahi Officer, Damurhuda, .. Member (*ex-officio*)”.

- (m) In the Notification No. S.R.O. 304-L/81, dated the 5th September 1981 for entry (5) in the first column and the entry relating thereto in the second column, the following shall be *substituted*, namely :—

“(5) Upazila Nirbahi Officer, Madhukhali, .. Member (*ex-officio*)”.

 (5) Upazila Nirbahi Officer, Polash, Narsingdi Member (*ex-officio*)”.

(o) In the Notification No. S.R.O. 350-L/81, dated the 26th October, 1981 for entry (5) in the first column and the entry relating thereto in the second column, the following shall be *substituted*, namely :—

“(5) Upazila Nirbahi Officer, Kaliganj, Jessore ... Member (*ex-officio*)”.
