এস, আর, ও নং ১০৭-আইন/৯৮—Paurashava Ordinance, 1977 (Ord. XXVI of 1977) এর section 146 এ প্রদত্ত ক্ষমতাবলে সরকার Paurashava (Election) Rules, 1977 এর নিম্নরূপ অধিকতর সংশোধন করিল, যথা:—

উপরি-উক্ত Rules এর—(১) rule 2 এর—(ক) clause (g) এর পর নিম্নরূপ নতুন clause (gg) সন্নিবেশিত হইবে, যথা:—

“(gg) “general seat” means any seat, other than reserved seats, for the purpose of election of commissioners within the meaning of sub-section (1) of section 19 of the Ordinance;”;

(খ) clause (n) এর পর নিম্নরূপ নতুন clause (nn) সন্নিবেশিত হইবে, যথা:—

“(nn) “reserved seat” means any seat of a commissioner exclusively reserved for women under sub-section (3) of section 6 of the Ordinance;”;

and shall be signed by the proposer and seconder and shall be accompanied by a Treasury challan or Bank receipt or a receipt from the Returning Officer showing deposit made under rule 11 and a certificate signed by the candidate that he or she has consented to his or her nomination and that he or she is not subject to any disqualification under sub-section (2) of section 10 of the Ordinance for being elected as Chairman or commissioner, as the case may be:

Provided that—

(a) any voter of any ward may subscribe only one nomination paper either as a proposer or a seconder for election of Chairman.

(b) any voter of a ward for general seat may subscribe only one nomination paper either as a proposer or a seconder for election of commissioner for that ward, and

(c) any voter of a ward for reserved seat may subscribe only one nomination paper either as a proposer or seconder for election of commissioner for that ward;”;

Provided that where more polling stations than one have been provided for a ward, the Presiding Officer shall, in the presence of the contesting candidates or their election agents or polling agents, after

counting, prepare a statement in Form J1 and shall, with the signature of the contesting candidates or their election agents, or polling agents, send the same to the Returning Officer, and thereafter the provisions of sub-rule (5) shall apply, *mutatis mutandis*, for the consolidation of the result of count for the commissioner of a ward for general seat”;
