

No. S.R.O.138-L/82.—In exercise of the powers conferred by section 10 of the Censorship of Films Act, 1963 (XVIII of 1963), the Government is pleased to make the following amendment in the Bangladesh Censorship of Films Rules, 1977, namely:—

In the aforesaid Rules, in rule 11, for the word and figure "Taka 25" the word and figure "Taka 35" shall be substituted.

2. It shall be deemed to have taken effect on the 1st day of July, 1981.

is pleased to make the following further amendment in the Wealth-tax Rules, namely:---

In the aforesaid rules, in rule 8, for sub-rule (3) following shall be substituted, namely:—

"(3) Land and buildings.—The value of lands and buildings shall be estimated with due regard to the nature and size of the property, the amenities available and the price prevailing for similar assets in the same locality or the neighbourhood of the said locality:

Provided that the Deputy Commissioner of Taxes shall not, except with the prior approval of the Inspecting Joint Commissioner of Taxes, estimate a value higher than a sum equal to twenty times the gross annual rental value of such property.

Explanation.—For the purposes of this sub-rule, "gross annual rental value" means the sum for which the property might reasonably be expected to let from year to year."
