No. S.R.O.144-L/84.—In exercise of the powers conferred by Article 82 of the Bangladesh Bank Order, 1972 (P. O. No. 127 of 1972), the Board of Directors of the Bangladesh Bank, with the approval of the Government, is pleased to make the following further amendment in the Bangladesh Bank General Regulations, 1977, namely:—

In the aforesaid Regulations, in regulation 19, in sub-regulation (2), under the heading "Scales",—

- (a) in clause (i), for the words "first class" the words "highest class" shall be substituted; and
- (b) in clause (ii), after the words "Taka one", the words "and poisha fifty" shall be inserted.
- 2. This Notification shall be deemed to have taken effect on the 3rd August, 1983.
