**IN THE COURT OF THE CHAIRMAN
SPECIAL MARTIAL LAW COURT No. X, MYMENSINGH
NOTIFICATION**

Whereas it has been made to appear to this Court that the following accused persons of the undernoted case are required for the purpose of trial in the Special Martial Law Court No. X, Mymensingh;

And whereas this Court has reason to believe that the said accused persons are absconding themselves to avoid appearance or arrest for the purpose;

Now, therefore, in exercise of the powers conferred by Regulation 3(7) of M.L.R. I of 1975, this Special Martial Law Court No. X, Mymensingh, directs the following five accused persons to appear before this Court within seven days of publication of this notification, failing which they will be tried *in absentia* and their properties may be forfeited to the Government:

- (4) Accused Agha Mohammad Aminuzzaman, formerly Thana Family Planning Officer, Sreebordi, son of late Md. Badiuzzaman, Vill. Amlapara, P.S. Jamalpur, Dist. Mymensingh.
- (5) Accused Md. Joynal Abedin, formerly Steno to D.P.C. and Family Planning Officer, Mymensingh, son of Iman Ali Munshi, Vill. Bahirkanda, P.S. Phulpur, Dist. Mymensingh.
