Provided that after publication of the final list of polling stations, the Election Commission may, in special circumstances, change a polling station.

- (3) The Returning Officer shall provide each ward with such number of polling stations as are specified in the final list published under sub-rule (2).
- (4) No polling station shall be located in any premises other than public places.
- (5) Each polling station may contain as many polling compartments as may be necessary for voting by male and female voters separately; and each such polling compartment may contain as many marking places as may be necessary,";

Returning Officer add to such list the required number of new symbols.";

- "30. Admission to polling station.—(1) The Presiding Officer shall, subject to such direction as the Commission may give in this behalf, regulate the number of voters to be admitted to the polling station at a time and exclude from the polling station all other persons except—
 - (a) any person on duty in connection with election;
 - (b) the contesting candidates, their election agents and one polling agent for each polling compartment; and

- (c) such other person as may be specifically permitted by the Returing Officer.
- (2) The Presiding Officer shall allow the entry of such number of voters into the polling compartments at a time as he may consider convenient:

Provided that not more than one voter shall be admitted into a marking place at a time and the presiding officer shall ensure that the secrecy of voting is maintained.

- (3) No contesting candidate, election agent or polling agent of a contesting candidate shall be admitted into the marking place reserved for marking ballot papers except for recording his own vote.
- (4) Members of the agencies for the maintenance of law and order shall be on duty whether inside or outside each polling station as the Presiding Officer may direct, and they shall under the orders of the Presiding Officer assist in expediting and regulating the passage of voters inside the polling station and maintaining order whether inside or outside the polling station.";

 - "38. Procedure on the conclusion of poll.—(1) On the conclusion of the poll in a polling station, the Presiding Officer shall, in the presence of the contesting candidates or their election agents or polling agents, if present, satisfy himself that the seals affixed to the used ballot box or boxes are intact and shall, after such satisfaction, take out the ballot papers from those ballot box or boxes.

- (2) The Presiding Officer shall, after taking out the ballot papers from the used ballot box or boxes,—
 - (a) separate the ballot papers meant for the election of Commissioner and Mayor;
 - (b) separate the ballot papers which are unambiguously marked in favour of a contesting candidate from the following invalid ballot papers which bear—.
 - (i) no official mark and initial of the issuing officer, or
 - (ii) any writing other than the initial of the issuing officer or any mark other than the official mark and the voting mark made with the stamp supplied for the purpose or to which a piece of paper or any other object of any kind has been attached; or
 - (iii) no voting mark with the stamp indicating the contesting candidate for whom the voter has voted; or
 - (iv) more than one voting mark meant for the contesting candidate;
 - (v) any mark from which it is not clear for whom the voter has voted: Provided that a ballot paper shall be deemed to have been marked in favour of a contesting candidate if the whole or more than half of the voting mark made with the stamp appears clearly within the space containing the name and symbol of that candidate, and where such mark is divided equally between two such spaces the ballot paper shall be deemed to be an invalid ballot paper;
- (3) The Presiding Officer shall also open the packet labelled "challenged ballot papers" and—
 - (a) separate the ballot papers meant for the election of Commissioner and Mayor;
 - (b) separate the ballot papers which are unambiguously marked in favour of a contesting candidate from the ballot papers which suffer from any of the defects mentioned in sub-clauses (i) to (v) of clause (b) of sub-rule (2).
- 39. Counting of votes.—(1) After scrutinising the ballot papers in accordance with the provisions of rule 38, the Presiding Officer shall, in presence of the contesting candidates or their election agents or polling agents, if present—
 - (a) count separately the valid votes cast in favour of each contesting candidate including the valid votes recorded in the ballot papers kept in the separate packet labelled "Challenged ballot papers";

- (b) prepare the statement of the count in FORM-J for Commissioner and in FORM J-1 for Mayor;
- (d) transmit the said statements alongwith the packet labelled "Challenged ballot papers" and other papers and materials, to the Returning Officer in accordance with the provisions of rule 39A.
- (2) The Presiding Officer may recount the votes-
- (a) on his own motion, if he considers necessary; or
- (b) upon the request of a contesting candidate or any election agent or any polling agent present at the time of count, if in his opinion, the request is not unreasonable.
- 39A. Papers etc. to be sealed in packets.—(1) The Presiding Officer shall—
 - (a) put in separate packet the valid ballot paper showing votes cast in favour of each contesting candidate;
 - (b) seal and sign each such packet with indication as to the number of valid ballot papers kept therein and the name and symbol of the contesting candidate to whom the packet relates;
 - (c) put in a principal packet all the individual packets containing the valid ballot papers meant for the election of Commissioner;
 - (d) similarly put in a different principal packet all the individual packets containing the valid papers meant for the election of Mayor;
 - (e) seal and sign the principal packets referred to in clauses (c) and (d) with indications as to the number of individual packets kept therein.
- (2) The invalid ballot papers meant for election of Commissioner and Mayor excluded from the count shall be put in separate packets indicating thereon the total number of ballot papers and such packets shall be sealed and signed by the Presiding Officer.

- (3) The Presiding Officer shall also enclose and seal into separate packets the following papers and materials and indicate on each such packet the nature of the contents:—
 - (a) un-issued ballot papers;
 - (b) challenged ballot papers;
 - (c) spoilt and cancelled ballot papers;
 - (d) the marked copies of the electoral rolls;
 - (e) counterfoils of used ballot papers;
 - (f) the list of challenged votes;
 - (g) official mark, stamp and brass seal;
 - (h) such other papers and materials as the Returning Officer may direct.
- (4) The Presiding Officer shall separately prepare a ballot paper account in Form K in respect of Commissioner and another ballot paper account in Form K-1 in respect of the election of Mayor.
- (5) The Presiding Officer shall obtain on each statement and packet sealed and signed by him under this rule signature of such of the contesting candidates or their election agents or polling agents as are present and as are willing to sign it.
- (6) The Presiding Officer shall, if so requested by any contesting candidate or election agent or polling agent, issue to him a duly attested copy of the statement of the count prepared in Form J or J-1, as the case may be, and also a copy of the ballot paper account prepared in Form-K or K-1, as the case may be.
- (7) The Presiding Officer shall, without delay, send to the Returning Officer the packets, the statements of count and ballot paper accounts prepared by him and such other record and materials as were received by him.
- 40. Consolidation and declaration of result.—(1) On receipt of the statements in FORM J and J-1, the ballot paper accounts prepared in FORM K and K-1 and the packets containing inavlid votes, the Returning Officer shall—
 - (a) publish in the notice board of his office a notice specifying the day, time and place for the consolidation and declaration of result of the election;
 - (b) on the day and at the time and place so specified consolidate in FORM L and FORM L-1, the results of the election of Commissioner and Mayor respectively.

- (2) Before consolidating the results, the Returning Officer shall-
- (a) examine the invalid ballot papers and also the invalid ballot papers out of the challenged ballot papers which were excluded from the count by the Presiding Officer;
- (b) if he finds that any such ballot paper should have not been so excluded, count it as a valid ballot paper showing vote cast in favour of the contesting candidate concerned;
- (c) record the fact of such counting in the consolidated statement concerned with a "+" (plus) mark beside the concerned number of valid votes;
- (d) where ballot papers are counted as valid votes as per clause (c), put such ballot papers in a separate fresh packet and the remaining ballot papers in another fresh packet and shall put both such packets along with the emptied packet sent by the Presiding Officer in a bigger packet;
- (e) where no ballot paper is counted as a valid one, put all the ballot papers alongwith the emptied packet sent by the Presiding Officer in a fresh packet;
- (f) seal and sign each fresh packet and the bigger packet referred to in clauses (d) and (e) with indications as to the number and nature of the ballot papers kept therein and shall ensure that the ballot papers sent by the Presiding Officer as invalid ballot papers and challenged ballot papers are not mixed with each other;
- (g) shall take, on the consolidated statement in FORM L or L-1 as the case may be and also on the packets which he has signed under clause (f), signatures of the contesting candidates or their election agents as are present and as are willing to so sign.
- (3) Where, after consolidation of the results of the count under this rule, it is found that there is equality of votes between two or more contesting candidates, the Returning Officer shall forthwith draw a lot in the manner as he deems fit and proper in respect of such candidates; and the candidate on whom lot falls shall be deemed to have secured the highest number of votes entitling him to be declared elected as a Commissioner or Mayor, as the case may be. The lot shall be drawn in presence of such of the contesting candidates or their election agents as may be present. The Returning Officer shall record the proceedings in writing and obtain thereon the signature of such candidates or their election agents as have been witness to the proceeding and record the result of the lot in FORM-L in the case of Commissioner and in the Election Return in FORM-L-2 in the case of Mayor.

- (4) After consolidating the result, of the count under sub-rules (1) and (2) or, as the case may be, after drawing the lot under sub-rule (3), the Returning Officer shall—
 - (a) declare in FORM-L the contesting candidate to be the elected Commissioner for the concerned ward who has secured or is deemed to have secured the highest number of votes; or
 - (b) prepare an Election Return in FORM-L-2 and declare therin the contesting candidate to be the elected Mayor who has secured or is deemed to have secured the highest number of votes;
 - (c) upon request of any contesting candidate or his election agent, issue to him a duly attested copy of the consolidated statement prepared in FORM-L or as the case may be, FORM-L-1 and of the Election Return prepared in FORM-L-2."

Definition of election expenses —In this Part, "election expenses" means any expenditure incurred or payment made, whether by way of gift, loan, advance deposit or otherwise, for the arrangement, conduct or benefit of or in connection with or incidental to, the election of a contesting candidate including the expanditure on account of issuing circulars or publications or otherwise presenting to the voters the candidate's views, aims or objects, but does not include the deposit made under rule 13.
- 44B. Statement of probable election expenses and sources.—(1) Every contesting candidate shall submit to the Returning Officer, within seven days next following the withdrawal day, a statement, in Form-N of the probable sources of fund to meet his election expenses showing—
 - (a) the sum to be provided by him from his own income and the sources of such income;
 - (b) the sum to be borrowed, or received as voluntary contribution, from his relations and the sources of their income;
 - (c) the sum to be borrowed, or received as voluntary contribution, from any other person;

- (d) the sum to be received as vountary contribution from any organisation, political party or other association; and
- (e) the sum to be received from any other source.

Explanation.—In this sub-rule "relations" means spouse, parents, sons, daughters, brothers and sisters.

- (2) The Statement under sub-rule (1) shall be accompanied by a statement in Form-O of the contesting candidate's assets and liabilities and his annual income and expenditure and, if he is an income tax assessee, a copy of the income-tax return last submitted by him,
- (3) A copy of the statement submitted under sub-rule (1) together with a copy of the statement and the return mentioned in sub-rule (2) shall be sent by the contesting candidate to the Election Commission by registered post at the time of their submission to the Returning Officer.
- (4) If the contesting candidate receives any sum from any source other than any of the sources mentioned in his statement submitted under sub-rule (1), he shall, within three days after receipt of such sum, submit a supplementary statement to the Returning Officer showing the sum so received and the source from which it is received, and a copy of such statement shall be sent by him to the Election Commission by registered post at the time of its submission to the Returning Officer.
- 44C. Limit of election expenses etc.— (1) No person shall, except to the extent provided in sub-rules (2) and (3) make any payment whatsover towards the election expenses of a contesting candidate.
- (2) No person other than the election agent of a contesting candidate shall incur any election expenses of such candidate:

Provided that-

- (a) a contesting candidate for election as Mayor himself may incur a
 personal expenditure in connection with his election of an amount
 not exceeding Taka 50,000 (fifty thousand);
- (b) a contesting candidate for election as Commissioner himself may incur a personal expenditure in connection with his election of an amount not exceeding Taka 5000 (five thousand); and
- (c) any person may, if so authorised by the election agent in writing specifying a maximum amount to the extent of such amount, make payment for stationery, postage, telegram and other petty expenses.
- (3) The election expenses of a contesting candidate for election as Mayor shall not exceed Taka 5,00,000 (five lakh) excluding the personal expenditure

specified in sub-rule (2) and that of a contesting candidate for election as Commissioner, shall not exceed Taka 50,000 (fifty thousand) excluding the personal expenditure specified in that sub-rule.

- (4) The amount of the money mentioned in sub-rules (2) or (3) or any portion thereof shall not be utilised for—
 - (a) printing of a poster with more than one colour; or
 - (b) use of any imported paper for printing of posters or leaflets; or
 - (c) erection of any gate or arch; or
 - (d) setting up of a pandal covering an area of more than four hundred square feet; or
 - (e) making any banner by using any cloth; or
 - (f) employing or using more than two microphones or loudspeakers at a time in a ward; or
 - (g) commencing election publicity in any manner at any time three weeks prior to the date fixed for the poll; or
 - (h) setting up of more than four election camps or offices in a Ward; or
 - (i) using any vehicle or vessel such as truck, bus, car, taxi, motor cycle and speed-boat, for taking out any procession; or
 - (j) illumination by use of electricity in any form; or
 - (k) using symbol or portrait of a candidate with more than one colour; or
 - (1) display of an election-symbol execeeding the size prescribed by the Election Commission.
- (5) Any candidate incurring personal expenditure and any person making any payment under sub-rule (2) shall, within seven days of the declaration of the result of the election, send to the election agent a statement of such expenditure of the particulars of such payment.
- 44 D. Return to be submitted by election agent.—(1) Every election agent of a contesting candidate shall, within fifteen days after the publication of the name of the returned candidate under rule 41, submit to the Returning Officer a return of election expenses in Form-P containing—
 - (a) a statement of all payments made by him each day since the withdrawal day together with all the bills and receipt/vouchers in respect of such payment;
 - (b) a statement of the amount of personal expenditure, if any, incurred by the contesting candidate;

- (c) a statement of all disputed claims of which the election agent is aware;
- (d) a statement of all unpaid claims, if any, of which the election agent is aware;
- (e) a statement of all sums received from any sources, together with evidence of such receipts, for the purpose of election expenses specifying the name of every such source.
- (2) The return submitted under sub-rule (1) shall be accompanied by an affidavit in Form-Q or Q-1 or Q-2s worn in separately by the contesting candidate or his election agent or, where a contesting candidate is his own election agent, only by such candidate, as the case may be;
- (3) A copy of the return submitted under sub-rule (1), together with a copy of the affidavit mentioned in sub-rule (2), shall be sent by the election agent to the Election Commission by registered post at the time of their submission to the Returning Officer,";
