Dacca, the 14th May, 1977.

No. 25/1/77-Rules-224.—The President has been pleased to constitute the Narayanganj Town Development Committee with immediate effect.

1. **Composition of the Committee.**—(1) The Committee shall consist of the following, namely :—

(a) Commissioner, Dacca Division—*Chairman*.

(b) Deputy Commissioner, Dacca—*Vice-Chairman*.

*Members.*

(c) Additional Deputy Commissioner (Development), Dacca.

(d) Subdivisional Officer, Narayanganj.

(e) Chairman, Narayanganj Municipal Committee.

(f) The three full-time members of the Dacca Division Development Board.

- (g) District Engineer, Zilla Board, Dacca.
- (h) One representative of the Narayanganj Chamber of Commerce.
- (i) Two representatives of the Educational Institutions of Narayanganj Town, to be nominated by the Deputy Commissioner, Dacca.
- (j) Six representatives of Narayanganj Town, to be nominated by the Chairman.
- (k) Two representatives from industries, to be nominated by the Chairman.

(2) The Chairman shall be the chief executive of the Committee.

(3) One of the members, to be specified by the Chairman, shall act as the Secretary of the Committee.

2. **Meetings of the Committee.**—(1) Save as hereinafter provided, the Committee shall regulate the procedure for its meetings.

(2) Meetings of the Committee shall be held on such dates and at such time and place as may be determined by the Chairman:

Provided that at least one meeting shall be held in every month.

(3) All meetings of the Committee shall be presided over by the Chairman or, in his absence, by the Vice-Chairman of the Committee.

3. **Functions of the Committee.**—The functions of the Committee shall be—

- (a) Preparation and execution of development schemes for Narayanganj Town area, either by the Committee or by some other agencies on its behalf;
- (b) Co-ordination of Development Projects undertaken by different Government, Semi-Government and Autonomous Agencies within Narayanganj Town Area;
- (c) Any other functions assigned to it by the Government from time to time.

4. **Appointment of staff, etc.**—The Committee may appoint such officers and staff on such terms and conditions as may be approved by the Government in the Cabinet Division.

5. **Funds and financial powers.**—(1) The Committee shall receive grants from Government from time to time from the development budget. The fund shall be utilised by the Committee to meet charges in connection with its functions under this notification, including the payment of salaries and other remuneration to the officers and other employees of the Committee.

(2) The Commissioner, Dacca Division and Chairman of the Committee shall be the Drawing and Disbursing Officer of the Committee. -

(3) The funds received from the Government by the Committee shall be kept in PL Account.

(4) The Committee shall maintain its accounts as per existing Government Rules.

(5) The accounts of the Committee shall be audited by the Comptroller and Auditor-General of Bangladesh in such manner as he deems fit.

6. The Government may, from time to time, issue directions to the Committee to take such measures as it considers necessary for carrying out the purposes of this notification; and the Committee shall comply with all such directions.

**No. 26/2/77-Rules-225.**—The President has been pleased to constitute the Mirpur Development Committee with immediate effect.

1. **Composition of the Committee.**—(1) The Committee shall consist of the following, namely :—

(a) Commissioner, Dacca Division—*Chairman*.

(b) Deputy Commissioner, Dacca—*Vice-Chairman*.

*Members.*

(c) Chairman, Mirpur Municipal Committee.

(d) The three full-time members of the Dacca Division Development Board.

(e) District Engineer, Zilla Board, Dacca.

(f) Two representatives of Mirpur Paurashava.

(g) One representative of the Dacca Chamber of Commerce.

(h) Two representatives of the Educational Institutions of Mirpur Paurashava, to be nominated by Deputy Commissioner, Dacca.

(i) Six representatives of Mirpur Town, to be nominated by the Chairman.

(j) One representative of WASA, Dacca and one representative from industrial units, to be nominated by the Chairman.

(2) The Chairman shall be the chief executive of the Committee.

(3) One of the members, to be specified by the Chairman, shall act as the Secretary of the Committee.

2. **Meetings of the Committee.**—(1) Save as hereinafter provided, the Committee shall regulate the procedure for its meetings.

(2) Meetings of the Committee shall be held on such date and at such time and place as may be determined by the Chairman :

Provided that at least one meeting shall be held in every month.

(3) All meetings of the Committee shall be presided over by the Chairman or, in his absence, by the Vice-Chairman of the Committee.

3. **Functions of the Committee.**—The functions of the Committee shall be—

(a) Preparation and execution of development schemes for Mirpur Town Area, either by the Committee or by some other agencies on its behalf;

(b) Co-ordination of development projects undertaken by different Government, Semi-Government and Autonomous Agencies within Mirpur Town Area;

(c) Any other functions assigned to it by the Government from time to time.

4. **Appointment of staff, etc.**—The Committee may appoint such officers and staff on such terms and conditions as may be approved by the Government in the Cabinet Division.

5. **Funds and financial powers.**—(1) The Committee shall receive grants from Government from time to time from the development budget. The fund shall be utilised by the Committee to meet charges in connection with its functions under this notification, including the payment of salaries and other remuneration to the officers and other employees of the Committee.

(2) The Commissioner, Dacca Division and Chairman of the Committee shall be the Drawing and Disbursing Officer of the Committee.

(3) The funds received from the Government by the Committee shall be kept in PL-Account.

(4) The Committee shall maintain its accounts as per existing Government Rules.

(5) The accounts of the Committee shall be audited by the Comptroller and Auditor-General of Bangladesh in such a manner as he deems fit.

6. The Government may, from time to time, issue directions to the Committee to take such measures as it considers necessary for carrying out the purposes of this notification; and the Committee shall comply with all such directions.
