NOTIFICATION

Dacca, the 4th May 1976.

No. S.R.O. 152-L/76—In exercise of powers conferred by section 12 of the Irrigation (Imposition of Water Rate) Ordinance, 1963 (E.P. Ordinance No. VII of 1963), the Government is pleased to direct that the power conferred and duty imposed upon the Government by sub-sections (2) and (3) of section 4 of the said Ordinance shall be exercised and performed by the Commissioner of the Division concerned.

No. S.R.O. 153-L/76—Whereas the Government is of opinion that the land under cultivation within the mouzas described in the Schedule below, hereinafter referred to as the Scheduled mouzas, are benefited or are likely to be benefited by irrigation water, supplied or regulated by the Bangladesh Water Development Board;

Now, therefore, in exercise of powers conferred by sub-section (1) of section 4 of the Irrigation (Imposition of Water Rate) Ordinance, 1963 (E. P. Ordinance No. VII of 1963), the Government is pleased to declare its intention to impose water rate in the Scheduled mouzas at the rate of three per cent. of the gross increased benefits accruing to the owners or occupiers of lands under cultivation within the Scheduled mouzas as a result of the supply or regulation of irrigation water to such lands ;

Provided that no water rate shall be imposed on lands which are not under cultivation;

Any person who is interested in any land likely to be affected by the imposition of the water rate may prefer objection to the Government to the intended imposition of water rate, or the rate at which the water rate is intended to be imposed or to the inclusion of such land in the areas concerned within one month from the date of publication of this notification in the official Gazette.

Now, therefore, in exercise of the powers conferred upon me under Article 3(7) of the Martial Law Regulations, I, Noor Md. Husain, Member, Summary Martial Law Court, Dinajpur, do hereby direct:—

- (a) the said Mr Bachhu to appear in my Court at Dinajpur on the 12th day of May 1976 at 10 a.m.; and
- (b) failing which all the movable and immovable properties standing in the name of said Mr Bachhu shall be attached.
