No. S.R.O. 153-L/80/2-N&L.—In exercise of the powers conferred by section 86 of the Excise Act, 1909 (Ben. Act V of 1909), the Government is pleased to make the following amendment in the Excise (Foreign Liquor Licence Fee) Rules, 1942, namely:—

In the aforesaid Rules, for rule 5 the following shall be substituted, namely:-

"5(1). The holder of a licence for the sale of foreign liquor for consumption "off" the premises including sale of medicated wine by a chemist under the Table below rule 4, shall pay, in addition to the annual licence fees mentioned in column (11) of the said Table, a monthly fee on the basis of the quantities of such liquor sold during the previous month at the rates specified in the following table:—

(2) The holder of a licence for the sale of foreign liquor for consumption "on" the premises under the Table below rule 4, shall pay, in addition to the annual licence fees mentioned in column (II) of the said Table, a monthly fee on the basis of the quantities of such liquor sold during the previous month at the rates specified in the following Table: -

- (c) 8 bottles containing more than 13 ounces but not less than 22
 - (d) 12 bottles containing not more than 13 ounces and not less than 11 ounces, or
 - (e) 24 bottles containing less than 11 ounces.".

No. S.R.O. 158-L/80/7-N&L.—In exercise of the powers conferred by section 86 of the Excise Act, 1909 (Ben. Act V of 1909), the Government is pleased to make the following amendment in the Excise (Foreign Liquor Licence Fee) Rules, 1942, namely:—

In the aforesaid Rules, for rules 3 and 4 the following shall be substituted, namely:—

- "3. Licences for the wholesale vending, compounding, blending and bottling of foreign liquor.—
 - (i) A holder of a licence for the wholesale vend of foreign liquor (other than denatured spirit) shall pay in advance an annual fee of Taka 4,000 00.

- (ii) A holder of a licence for the compounding and blending of foreign liquor shall pay in advance an annual fee of Taka 3,000.00.
- (iii) A holder of a licence for the bottling of portable foreign liquor shall pay in advance an annual fee of Taka 500.00.
- 4. Annual licence fees of foreign liquor and other kinds of licences .-The holder of a licence mentioned in column (I) of the following Table shall pay in advance an annual licence fee mentioned in column (II) thereof:

- (i) Licence for the sale of foreign liquor to the Taka 1,000-00 public for consumption "Off" the premises.
- (ii) Licence for the sale of foreign liquor to the Taka 1,000.00 public for consumption "On" the premises, except hotels, restaurants, bars in hotels, restaurants, theatres, cinemas or other permanent places of amusement.
- (iii) Licence for the sale of foreign liquor in a Taka 1,000.00 hotel.
- (iv) Licence for the sale of foreign liquor in a Taka 1,000 00 restaurant.
- (v) Bar licence for the sale of foreign liquor Taka 1,000 00 tenable for the holder of a hotel or restaurant licences.
- (vi) Bar licence for the sale of foreign liquor in Taka 1000.00 theatres, cinemas or other permanent public places of amusement.
- (vii) Licence for the sale of foreign liquor in a Taka 1,000.00 railway refreshment room.
- (viii) Licence for the sale of foreign liquor in a Taka 1,000 00 dining car, steamer or dak-bungalow.
- (ix) Licence for the sale of foreign liquor in a Taka 2,000 00. club, mess or other similar institution.
 - (x) Licence for the sale of foreign liquor in a Taka 1,000.00 military canteen.
- (xi) Licence for the sale of medicated wine by a Taka 1,000.00 licenced dealer (wholesale).

(xii) Licence for the sale of medicated wine by a licenced chemist and druggist:

(a) Within a Pourasava area ... Taka 750.00

(b) In other areas ... Taka 500.00

(xiii) Licence for the sale of Mritasanjibani Su-Taka 1,000.00 dha or Sura by wholesale.

(xiv) Licence for the sale of Mritasanjibani Sudha Taka 250.00 or Sura by retail.

(xv) Licence for the storage of rectified spirit at a Taka 250.00 concessional rate of duty for the manufacture of bona fide medicinal preparations.

(xvi) Licence for the manufacture of perfumes and Raka 250:00 toilet preparations containing alcohol.

(xvii) Licence for the wholesale vend of denatured Taka 1000-00 spirit.

(xviii) Licence for the retail vend of ordinary Taka 250-00 denatured spirit.

(xix) Licence for the possession of ordinary denatured spirit for business purposes in excess of the quantity fixed as the limit for private possession.

(xx) Licence for the storage of rectified spirit Taka 1,000.00" obtained at a concessional rate of duty for the use in the manufacture of Homoco Mother Tincture.
