NOTIFICATION

Dhaka, the 24th April, 1984

No. S.R.O. 157-L/84.—In exercise of the powers conferred by Article 24 of the Bangladesh Industrial Enterprises (Nationalisation) Order, 1972 (P.O. No. 27 of 1972), the Government is pleased to make the following rules, namely:—

THE BANGLADESH JUTE MILLS CORPORATION AND ENTERPRISES
EMPLOYEES (SENIORITY OF FREEDOM FIGHTERS) RULES, 1984.

1. **Short title.**—These rules may be called the Bangladesh Jute Mills Corporation and Enterprises Employees (Seniority of Freedom Fighters) Rules, 1984.

2. **Rules to override other rules, etc.**—These rules shall have effect notwithstanding anything contained in any other rules, orders or instructions relating to seniority or other conditions of service of employees for the time being in force.

3. **Definitions.**—In these rules, unless there is anything repugnant in the subject or context,—

- (a) "employee" means an officer or other employee employed with the Bangladesh Jute Mills Corporation or with any industrial enterprise under it;

- (b) "freedom fighter" means any of the following persons who is in the employment of Bangladesh Jute Mills Corporation or any industrial enterprise under its control and who, being employee on 25th March, 1971 of the erstwhile Government of Pakistan or East Pakistan or East Pakistan Industrial Development Corporation or of any local authority or statutory Corporation in the then East Pakistan or West Pakistan, participated in the war of liberation, namely:—
- (i) officially reported to the Government of Bangladesh at Mujibnagar and was accepted by the Government of Bangladesh;
 - (ii) abstained from his duty under the occupation regime and did not receive salary from that regime with a view to participating in the liberation struggle, whether staying inside or outside Bangladesh, for a continuous period of not less than three months immediately preceding the 3rd of December, 1971 but could not formally report to the Government of Bangladesh at Mujibnagar;
 - (iii) expressly declared his allegiance to the Government of Bangladesh at Mujibnagar from abroad;
 - (iv) worked for the liberation struggle and carried out instructions of the Government of Bangladesh at Mujibnagar during the period between the 17th April to 16th December, 1971; and
 - (v) suffered imprisonment or detention in the hands of the occupation army and on release was not reinstated or was dismissed or removed from service or did not join service before the 16th December, 1971.

4. **Ante-dated Seniority.**—A freedom fighter shall be given two years ante-dated seniority in the post held by him on the 25th March, 1971, with all attendant benefits in terms of promotion and fixation of pay with effect from the 1st July, 1978.

5. **Fixation of pay.**—Upon the grant of two years ante-dated seniority under these rules to a freedom fighter, the pay of the freedom fighter shall be refixed having regard to such seniority but no arrears of pay shall be admissible to him on account of such refixation.

6. **Rules not to apply in certain cases.**—Where any freedom fighter had been given any promotion only on account of his having participated in the war of liberation, any promotion for which he would not have been considered on account of his relative seniority, the benefit of two years ante-dated seniority under these rules shall not be available to him in his promoted position.

Summary Martial Law Case No. 1/84

PROCLAMATION

Whereas it has been made to appear to me that the accused persons specified in the schedule below, hereinafter referred to as the said accused person, are required for the purpose of trial in Summary Martial Law Court No. 28;

And whereas the Court has reason to believe that the said accused persons are absconding or concealing themselves to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of the powers conferred by Regulation 2(11) of Martial Law Regulation No. I of 1982, this Summary Martial Law Court No. 28 at Sher-e-Bangla Nagar, Dhaka, do hereby direct the said accused persons to appear in this Court at 10 a.m. on 3rd June, 1984 in Ramna P.S. Case No. 24(4)83, failing which they will be tried *in absentia* and their properties, both movable and immovable, may be forfeited to the Government:

- (1) Md. Amir Hossain, son of Subhan Ali Munshi of Charbarigugra, P.S. Faridgonj, Dist. Comilla, at present 204-B, Khilgaon, P.S. Motijheel, Dist. Dhaka.
- (2) Md. Ali Faruque *alias* Faruque, son of Nazimuddin Chowdhury *alias* Dulara of 36, Abul Hasanat Rd., P.S. Kotwali, Dist. Dhaka.
