#### NOTIFICATION

Dhaka, the 6th April, 1985

No. S.R.O. 162-L/85/916/Cus.—In exercise of the powers conferred by subsection (1) of section 4 of the Sales Tax Ordinance, 1982 (XVIII of 1982), and section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to exempt the goods specified in column (2) of the table below and falling under the Tariff Heading Nos. of the First Schedule to the Customs Act, 1969 (IV of 1969), as specified in column (1) of the said Table from whole of the sales tax and so much of customs duties leviable thereon as is in excess of the rate specified in the corresponding entries in column (3) of that Table, provided that these goods are imported between the 11th day of May, 1985 and the 9th day of June, 1985 (both days inclusive):
