No. 155-E.—The Government have been pleased to constitute an Inter-Ministerial Committee to examine the existing system of allocation of residential accommodation to officers and staff of different Ministries and Divisions and recommend appropriate changes in the system with a view to decentralising the allocation of residential accommodations.

- 2. The Committee shall consist of the following:
- (1) Additional Secretary-in-Charge, Ministry of .. Chairman, Works.
- (2) Joint Secretary (Accommodation), Ministry of ... Member. Works.
- (3) to (7) Representatives (not below the rank of Joint Secretary) of Cabinet Division, Establishment Division, Finance Division, Law and Parliamentary Affairs Division, Land Administration and Land Reforms Division.
- (4) Director, Government Accommodation .. Member-Secretary.
- 3. The terms of reference of the Committee shall be as follows:-
 - (a) To review the existing system of providing residential accommodations to the officers and staff and identify the inadequacies of the system, keeping in view the policy of decentralisation.
 - (b) To recommend appropriate changes in the present system, taking into account the need to provide residential accommodation in close proximity of the offices, among others.
 - (c) To recommend re-organisation of the Accommodation Directorate in view of decentralization.
- (d) To recommend appropriate amendments in the existing "Bangladesh Allocation Rules, 1976".
- 4. The Committee will finalise its report along with the recommendations by 10th July, 1982.
