#### PROCLAMATION

## Martial Law Case No. 43/1977

Whereas it has been made to appear that Md. Kashem, son of Gunjar Ali of Vill. Gazipur, P.S. Chandpur, Dist. Comilla, is required for the purpose of trial in the Special Martial Law Court No. II, Ganabhaban, Dacca, u/s. 363/511, BPC.

And whereas this Court has reason to believe that the said accused person is absconding or concealing himself to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of powers conferred by Regulation 3(7) of M.L.R. 1/75 this Special Martial Law Court No. II, Ganabhaban, Dacca, do hereby direct—

"(a) Where the destination is outside Bangladesh .. Tk. 35.00

(b) Where the destination is within Bangladesh .. Tk. 5.00"
