No. S. R. O. 176-L/85/SVI/LC-4/85/229—Whereas Mr Shushil Kumar Paul, President Jatiyo Sramik League (B.N.F. II), Rani Bazar, Rajshahi, a member in the Panel in the Rajshahi Labour Court representing the Employees has not been attending the Court as he died on 22nd July, 1984 and in the opinion of the Government he has lost his representative Character. And Mr Alauddin Mirdha, President, Rajshahi Chini Kal Sramik Union (Rg. iiiii), Jatiyatabadi Sramik Dal, Rajshahi, a member in the panel of the Labour Court, Rajshahi representing Employees, has not been attending the Court as he has been transferred from Rajshahi to Dinajpur and in the opinion of the Government he has lost his representative Character.

Now, therefore, in exercise of the powers conferred by rule 37 of the Industrial Relations Rules, 1977, the Government is pleased to remove the said Mr Shushil Kumar Paul and Mr Alauddin Mirdha from the Panel of the members with immediate effect.
