No. S.R.O. 178-L/84/834/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to make the following further amendment in this Ministry's Notification No. S.R.O. 205-L/83/778/Cus., dated the 30th June, 1983, namely:—

In the aforesaid Notification, in the Table, for Tariff Heading No. 87.12 in column (1) and the entries relating thereto in columns (2) and (3), the following shall be substituted, namely:—

“87.12 Parts and accessories of cycle falling under sub-head B excluding frame, mud-guard, fork, chain-stay, back-stay, chain cover, carrier, stand, pedal, spoke, nipples and paper transfer of all foreign bicycles. . . 20% ad val.”

Martial Law Case No. 60/83
