No. S.R.O. 184-L/80/ST-6.—In exercise of the powers conferred by sub-section (1) of section 7 of the Sales Tax Act, 1951 (III of 1951), the Government is pleased to direct that in respect of the goods or class of goods specified in the Table below, when imported under the Passenger (Non-tourists) Baggage (Import) Rules, 1980, or the Transfer of Residence (Baggage) Rules, 1980, the rate of tax leviable thereon shall be reduced by one-half of the rate of tax leviable on normal import of such goods:
