No. 572-Pub.—The following Ordinance made by the President of the People's Republic of Bangladesh on the 15th June, 1976, is hereby published for general information:—

## THE BANGLADESH (FREEDOM FIGHTERS) WELFARE TRUST (AMENDMENT) ORDINANCE, 1976

Ordinance No. XXXVIII of 1976

## ORDINANCE

further to amend the Bangladesh (Freedom Fighters) Welfare Trust Order, 1972.

WHEREAS it is expedient further to amend the Bangladesh (Freedom Fighters) Welfare Trust Order, 1972 (P.O. No. 94 of 1972), for the purposes hereinafter appearing;

Now, THEREFORE, in pursuance of the Proclamations of the 20th August, 1975, and the 8th November, 1975, and in exercise of all powers enabling him in that behalf, the President is pleased to make and promulgate the following Ordinance:—

1. Short fitle.—This Ordinance may be called the Bangladesh (Freedom Fighters) Welfare Trust (Amendment) Ordinance, 1976.

- 2. Amendment of Article 7, P.O. No. 94 of 1972.—In the Bangladesh (Freedom Fighters) Welfare Trust Order, 1972 (P.O. No. 94 of 1972), hereinafter referred to as the said Order, in Article 7, for clause (1) the following shall be submitted, namely:—
  - "(1) The Board shall consist of the following persons to be appointed by the Government, namely:—
    - (a) a whole time Chairman who shall be the chief executive of the Trust; and
    - (b) such other persons as the Government may deem fit to appoint.".
- 3. Amendment of Article 8, P.O. No. 94 of 1972.—In the said Order, in Article 8, for the words "Managing Director" occurring twice the word "Chairman" shall be substituted in both the places.
- 4. Amendment of Article 9, P.O. No. 94 of 1972.—In the said Order, in Article 9,—
  - (a) in clause (1), for the words "Managing Director" the word "Chairman" shall be substituted; and
  - (b) for clause (2) tihe following shall be substituted, namely:-
    - "(2) In the absence of the Chairman, the powers and functions of the Chairman shall be performed by such officials of the Trust and the meetings of the Board shall be presided over by such Trustee as the Chairman may direct in writing,".
- 5. Amendment of Article 11, P.O. No. 94 of 1972.—In the said Order, in Article 11,—
  - (a) for the word "Chairman" the word "Board" shall be substituted; and
  - (b) for the word "he" the word "it" shall be substituted,

#### Dacca, the 17th June 1976.

- No. S.R.O. 184-L/76.—In exercise of the powers conferred by the proviso to article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Bangladesh Public Service (First) Commission as required by clause (2) of article 140 of the Constitution, is pleased to make the following rules, namely:—
- 1. Short title.—These rules may be called the Directorate of Social Welfare Gazetted Officers (Manager, Rehabilitation Officer and Placement Officer) Recruitment Rules, 1976.
- 2. Definitions.—In these rules, unless there is anything repugnant in the subject or context,—
  - (a) "Commission" means the Bangladesh Public Service (First) Commission;
  - (b) "Directorate" means the Directorate of Social Welfare;
  - (c) "Post" means a post specified in the Schedule; and
  - (d) "Schedule" means the Schedule annexed to the rules.
- Method of recruitment.—(1) Subject to the provisions of the Schedule, appointment to a post shall be made by promotion.
- (2) No person shall be appointed to a post unless he has the qualification and experience as laid down in the Schedule.
- (3) No appointment to a post shall be made except upon the recommendation of the Commission.

#### ORDER

#### Dacca, the 21st June 1976.

No. S.R.O.188-L/76.—In exercise of the powers conferred by sub-section (1) of section 8 of the Jute Ordinance, 1962 (LXXIV of 1962), the Government is pleased to fix, for the period beginning on the 1st day of July, 1976, and ending the 30th June, 1977, the minimum price of Jute at Taka ninety per maund at growers level all over Bangladesh below which loose jute of the lowest, that is, X-Bottom grade shall not be sold or purchased.

Explanation.—The specification of the X-Bottom grade shall be as follows:—

- (i) any strength and any colour;
- (ii) occasional croppy and gummy tops with cuttings and specks and hard centred jute; maximum proportion of cuttings shall hot exceed 40 per cent of the weight;
- (iii) generally corresponding to Bangla White 'D' when converted to pucca.
