No. COM/CG/PF-1(321)/75.—In exercise of the powers conferred by clause 3 of the Essential Commodities Price and Distribution Control Order, 1975, I, M. A. Matin, Controller-General of Prices and Supplies, Ministry of Commerce, Government of the People's Republic of Bangladesh, hereby re-fix the ex-distribution centre wholesale price of cement imported by TCB and locally produced by BMEDC's factories for the 7 distribution centres at Chattak, Chittagong, Dacca, Khulna, Barisal, Ishurdi and Santahar with immediate effect as under. This supercedes Ministry' of Commerce notification No. Com/CG/ PF-1(321)/75, dated the 19th May 1977:

Description.

(i) Imported cement in craft ... paper bag

(ii) Locally produced cement in .. Tk. 57 · 50 (Taka Fifty-seven gunny bags (Produced in Chittagong and Chattak factories)

Ex-distribution centre wholesale price (per bag).

Tk. 58 · 50 (Taka fifty-eight and paisa fifty only).

DCs/SDOs will fix maximum retail price for the respective areas taking into account the ex-distribution centre price, dealer's commission of Tk. 2·50 per bag and actual transportation and handling charges, etc. subject to a maximum of Tk. 2·50 per bag within a radius of 10 miles from the distribution centre so as to keep the maximum retail price at level not exceeding Tk. 62·50 per bag for locally produced cement packed in gunny bags and Tk. 63·50 per bag for imported cement packed in craft paper bags.

The maximum retail price for areas beyond the radius of 10 miles will consist of ex-distribution centre price, dealer's commission of Tk. 2.50 per bag and transportation and handling cost from the nearest (in terms of transport cost) distribution centre.

The maximum retail price of cement to be imported by the Private Importers will be fixed by DCs/SDOs at a level not exceeding the maximum retail price for cement imported by TCB for that area.

The public sector agencies and bulk-users in the Private Sectors will lift cement direct from MMEDC factories at Chattak and Chittagong and TCB godown at Chittagong and Khulna at the uniform wholesale price fixed for the distribution centres.

The dealer will receive delivery of cement from the nearest distribution centre (in terms of transport cost).
