- 2. The terms of reference for the Committee shall be as follows :-
  - (i) Recommend ways and means for promoting, organising and running suitable cottage industries;
  - (ii) Formulate comprehensive programmes and policy guide-lines for the development of cottage industries in the country;
- (iii) Identify the problems and bottlenecks inhibiting the development of cottage industries and recommend specific measures to solve them;
- (iv) Recommend priorities on the basis of employment of surplus manpower and saving and earning of foreign exchange;
- (v) Identify products of cottage industries which have a market within the country and products which can be exported;
- (vi) Recommend measures for improving marketing arrangements for these products at home and abroad;
- (vii) Examine existing financing arrangements for meeting the investment and working capital needs of cottage industries and recommend measures for institutional improvement in this area.
- 3. The Committee may co-opt members, if necessary.
- 4. The Committee shall submit its report to the Government within one month.
